## ADMINISTRATIVE PROCEEDINGS

### ADMINISTRATIVE PROCEEDINGS INSTITUTED, FINDINGS MADE AND SANCTIONS IMPOSED AGAINST JAMES WEBER

The Commission instituted administrative proceedings, made findings and imposed sanctions on James T. Weber (Weber) of Boca Raton, Florida. Weber was the financial and operations principal and a general-principal of Easter Kramer Group Securities, Inc., a registered broker-dealer which ceased operations in June 1991. Weber submitted, and the Commission accepted, an Offer of Settlement whereby he consented to the entry of an Order Making Findings and Imposing Remedial Sanctions containing findings that on July 10, 1991, a Final Judgment of Permanent Injunction was entered against Weber enjoining him from further violating or aiding and abetting violations of the broker-dealer books and records provisions and net capital requirements of the federal securities laws and Regulation T promulgated by the Board of Governors of the Federal Reserve System.

The Commission, based upon the findings and Weber's consent, barred Weber from association with any broker, dealer, municipal securities dealer, investment company or investment adviser provided, however, that after a period of three years subsequent to the entry of this Order he has a right to re-apply to the appropriate self-regulatory organization or, where there is none, to the Commission for permission to become so associated. ### ORDER INSTITUTING PROCEEDINGS AGAINST GARY KRAMER

The Commission instituted administrative proceedings under the Securities Exchange Act of 1934 (Exchange Act) against Gary Kramer (Kramer) of Boca Raton, Florida to determine what remedial action, if any, should be taken against him. Kramer was the secretary and a general principal of Easter Kramer Group Securities, Inc., a registered broker-dealer which ceased operations in June 1991.

The Order Instituting Proceedings alleges that on July 10, 1991 a permanent injunction was entered against Kramer in connection with a civil action filed by the Commission in June 1991, alleging violations and/or the aiding and abetting of violations by Kramer of Sections 7(c), 10(b), 15(c) and 17(a) of the Exchange Act and Rules 10b-5, 15c1-2, 15c3-1, 15c3-3, 17a-3, 17a-5, 17a-11, thereunder, and Regulation T promulgated by the Board of Governors of the Federal Reserve System. [SEC v. Dennis J. Easter, et al., USDC, SD Fla., Civil Action No. 91-8335-CIV-RYSKAMP.]

A hearing will be scheduled to determine what remedial sanctions, if any, should be imposed against Kramer. (Rel. 34-32173)

## INVESTMENT COMPANY ACT RELEASES

---

### CAPITAL VALUE FUND ET AL.

A notice has been issued giving interested persons until May 17, 1993 to request a hearing on an application filed by Capital Value Fund, Investors Management Group, IMG Financial Services, and Capital Value Corporation for a conditional order under Section 6(c) of the Investment Company Act. The conditional order would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit certain series of the Fund to issue two classes of shares representing interests in the same portfolio of securities, one of which would convert into the other class after a specified period permitting investors to benefit from lower Rule 12b-1 distribution fees. The order would also permit certain series of the Fund to assess a contingent deferred sales charge (CDSC) on certain redemptions of shares of one of the classes and to waive the CDSC under certain circumstances. ### BISON MONEY MARKET FUND

A notice has been issued giving interested persons until May 18, 1993 to request a hearing on an application filed by Bison Money Market Fund for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-19432 - April 23)

## HOLDING COMPANY ACT RELEASES

### SYSTEM ENERGY RESOURCES, INC., ET AL.

An order has been issued authorizing a proposal by System Energy Resources, Inc. (SERI), Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, and New Orleans Public Service, Inc., electric public-utility subsidiary companies of Entergy Corporation (Entergy), a registered holding company, and Entergy (collectively, Applicants). SERI proposes to issue and sell a new series of first mortgage bonds (Bonds) in the principal amount of \$60 million, bearing an interest rate of 6% and maturing on April 1, 1998. Jurisdiction is reserved over SERI's issuance and sale of up to \$220 million of the Bonds in one or more series, through December 31, 1994. (Rel. 35-25803)

### UTILICORP UNITED INC.

A notice has been issued giving interested persons until May 17, 1993 to request a hearing on a proposal by UtiliCorp United Inc. (UtiliCorp), a public-utility holding company claiming exemption from registration under Rule 10 of the Act. UtiliCorp proposes indirectly to acquire a 33.33% interest in WEL Energy Group Limited (WEL), a New Zealand electric utility, and requests an order under Section 3(b) granting WEL exemption from all provisions of the Act. ## GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing a proposal by General Public Utilities Corporation (GPU), a registered holding company. GPU proposes to extend through December 31, 2002 its authorization to guaranty certain non-funded payment obligations under various existing employee benefit plans offered by GPU Service Corporation (Service) and GPU Nuclear Corporation (Nuclear), each a subsidiary company of GPU. GPU further proposes to guarantee through December 31, 2002 certain non-funded payment obligations of Service and Nuclear under certain other employee benefit plans. (Rel. 35-25805)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
