## HOLDING COMPANY ACT RELEASES

---

### NATIONAL FUEL GAS COMPANY

An order has been issued regarding a proposal by National Fuel Gas Company (National), a registered holding company. National proposes to issue and sell, in one or more transactions through March 31, 1995, up to 2.5 million shares of its common stock (Additional Common Stock). National requests authority to issue and sell the Additional Common Stock under an exception from the competitive bidding requirements of Rule 50 under Subsection (a)(5) thereunder. National also proposes to use the proceeds from the sale of the Additional Common Stock to make capital contributions from time to time through March 31, 1995 to its wholly-owned subsidiaries, Seneca Resources Corporation, National Fuel Gas Distribution Corporation, National Fuel Gas Supply Corporation, Penn-York Energy Corporation and Utility Constructors, Inc. (Constructors). The Commission shall reserve jurisdiction over the contribution of proceeds from the sale of the Additional Common Stock to Constructors. (Rel. 35-25810)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
