## ADMINISTRATIVE PROCEEDINGS

---

### SECTION 12(j) REGISTRATION OF GREENWAY ENVIRONMENTAL SERVICES REVOKED

The Commission announced today that it has ordered the revocation of the registration of the common stock of Greenway Environmental Services, Inc. (Greenway), pursuant to Section 12(j) of the Securities Exchange Act of 1934. The Commission found that Greenway had filed a registration statement on Form 10 that contained materially false and misleading statements in violation of Section 10(b) of the Exchange Act and Rule 10b-5 thereunder.

Greenway has submitted an Offer of Settlement consenting to the entry of the Order without admitting or denying the allegations in the Order. (Rel. 34-32745)

### AETNA CAPITAL MANAGEMENT, AETNA FINANCIAL SERVICES, ORDERED TO CEASE AND DESIST

The Commission issued an Order finding that Aetna Capital Management, Inc. and Aetna Financial Services, Inc. violated the federal securities laws in connection with several undisclosed compensation arrangements with a securities broker who solicited purchasers for Aetna Life Insurance Company's variable annuities and Aetna Capital Management, Inc.'s investment advisory services. Pursuant to the arrangements, the broker and his designees received approximately \$1.8 million in undisclosed commissions and consulting fees. The Order requires Aetna Capital Management, Inc. to cease and desist from committing or causing violations of Sections 204, 206(2), 206(4) and 207 of the Advisers Act and Rules 204-1, 204-3 and 206(4)-3 promulgated thereunder and Sections 17(a)(2) and (3) of the Securities Act and to pay a \$500,000 penalty, and requires Aetna Financial Services, Inc. to cease and desist from committing or causing violations of Sections 17(a)(2) and (3) of the Securities Act.

The Order was issued pursuant to Sections 203(e), 203(i) and 203(k) of the Investment Advisers Act of 1940 and Section 8A of the Securities Act of 1933. The Commission accepted offers of settlement in which each respondent consented to the entry of the Order without admitting or denying the findings contained therein. (Rels. IA-1379 and 33-7011)

## CIVIL PROCEEDINGS

### PERMANENT INJUNCTION ENTERED AGAINST ROBERT TROUP

The Commission announced on August 19 that the Honorable T. F. Gilroy Daly, U.S. District Judge for the District of Connecticut, entered a Final Judgment of Permanent Injunction and Other Relief as to Robert Troup. The order permanently enjoined Troup from violating Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 thereunder. The action results from Troup's transactions in the securities of Gartner Group, Inc. The Final Judgment orders Troup to disgorge \$82,149.20, which represents his trading profits from his Gartner Group stock transactions, to pay prejudgment and postjudgment interest, and to pay a penalty of \$82,149.20 under the Insider Trading Sanctions Act. Based upon Troup's demonstrated financial condition, payment of all but \$10,000, representing partial disgorgement of his trading profits, was waived.

Troup consented to the entry of the Final Judgment in consideration of the Court's January 26 Judgment adopting and affirming the recommended ruling of a U.S. Magistrate Judge granting the Commission's motion for summary judgment and denying Troup's cross-motion for summary judgment, based on findings that Troup engaged in insider trading in the securities of Gartner Group in violation of the provisions cited above. (SEC v. Robert Charles Troup, et al., USDC Connecticut, Civil Action No. B 89-658, TFGD) (LR 13762)

### MCCARLEY & ASSOCIATES, EDWARD MCCARLEY JR. PERMANENTLY ENJOINED

The Commission announced that on August 16 that the Honorable G. Ross Anderson Jr. U.S. District Judge for the District of South Carolina, entered orders of permanent injunction against McCarley & Associates, Inc., a registered broker-dealer headquartered in Greenville, S.C., and the firm's president, Harold C. McCarley, Jr. The Commission's complaint alleged that those defendants have misappropriated over \$750,000 from customer accounts since June 1993, and that they have, since 1988, misappropriated an additional undetermined amount of money from their customers. The defendants consented to the orders, without admitting or denying the Commission's allegations. The orders permanently enjoin the defendants from violating, and aiding and abetting violations of, the antifraud, net capital, customer protection and books and records provisions of the Securities Exchange Act of 1934, order them to disgorge ill-gotten gains plus prejudgment interest, note the appropriateness of civil penalties, and order accountings, an asset freeze and the preservation of documents. The court reserved for later determination the amounts to be paid as disgorgement, prejudgment interest and penalties. (SEC v. McCarley & Associates and Harold C. McCarley, Jr., Civil Action No. 6 93-20323, D. S.C.) (LR-13760)

### JOHN VIDAKOVICH PERMANENTLY ENJOINED AND ORDERED TO PAY DISGORGEMENT

The Commission announced that on July 30 the U.S. District Court for the Central District of Utah issued a Final Judgment of Permanent Injunction and Other Equitable Relief against John B. Vidakovich. The Final Judgment enjoined Vidakovich from further violations of the antifraud, registration and reporting requirements of the federal securities laws and ordered him to pay disgorgement in the amount of \$155,000, plus prejudgment interest, but waived payment of those amounts based upon Vidakovich's inability to pay. Vidakovich consented, without admitting or denying the allegations contained in the Commission's Complaint, to the entry of the Final Judgment.

In its Complaint, the Commission alleged that from at least 1986 until November 1987, Vidakovich used his position as an undisclosed control person of Calico Corporation to make use of Calico's funds for non-corporate purposes, issue false and misleading press releases and file a false and misleading document with the Commission. Furthermore, the Commission alleged that Vidakovich sold Calico stock after manipulating the price of the stock. (SEC v. John L. Vidakovich, et al., USDC, Central District of Utah, Civil Action No. 91-C-1011W) (LR 13759)

### COLLEGE RETIREMENT EQUITIES FUND et al.

An order has been issued to College Retirement Equities Fund and TIAA-CREF Individual & Institutional Services, Inc. (collectively, "Applicants") pursuant to Section 6(e) of the Investment Company Act exempting the Applicants' distribution financing arrangement from the provisions of Sections 12(b), 26(a)(2) and 27(c) (2) of the Act and Rule 12b-1 thereunder; and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder, approving the same distribution financing arrangement. ### CASH RESERVE MANAGEMENT, INC.
