ENFORCEMENT PROCEEDINGS

VICTOR POSNER, STEVEN POSNER, AND PENNSYLVANIA ENGINEERING CORPORATION BARRED FROM SERVING AS OFFICERS AND DIRECTORS OF PUBLICLY HELD COMPANIES, DIVESTED OF CONTROL OF SUCH COMPANIES, AND ORDERED TO DISGORGE \$3.8 MILLION FOR VIOLATING SECTIONS 7, 10(b), 13(d), AND 17(a) OF THE EXCHANGE ACT

On December 1, following a full trial on the merits, Senior District Judge Milton Pollack of the Southern District of New York issued a memorandum opinion accompanied by findings of fact and conclusions of law in which he concludes that defendants Victor Posner, Steven Posner, and Pennsylvania Engineering Co., with the complicity of Michael Milken and Drexel Burnham Lambert, obtained control of Fischbach Corporation by fraudulent means and, in the process, violated sections 7, 10(b), 13(d), and 17(a) of the Securities Exchange Act of 1934 and rules and regulations thereunder. Based on its review of the Posners' "long and notorious history of engaging in self-dealing and corporate waste to the detriment of the public shareholders of companies under their control," the Court concludes "that one would be hard pressed to find more worthy candidates to be barred from serving as officers and directors." It will, accordingly, bar them from serving as officers or directors of any reporting company pursuant to recently enacted statutory authority. To ensure that the Posners do not attempt to circumvent the bar by exercising voting control, the Court will also require them to place the stock they own in any reporting company they control in a voting trust. The Court, in addition, will order disgorgement of \$3,864,010 and prospective injunctive relief.

The Court's barring the Posners from serving as officers and directors represents the first time that a court has imposed that statutory remedy in a litigated action. The ancillary voting trust ordered by the Court, although previously employed in settled cases, has also never previously been imposed in a litigated case. With the Court's decision against the Posners, the SEC has obtained judgments by consent or adjudication against all the defendants and all the relief it sought in the case. [SEC v. INVESTMENT COMPANY ACT RELEASES

AMERICAN NATIONAL INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until December 27 to request a hearing on an application filed by American National Insurance Company, American National Variable Annuity Separate Account (Separate Account) and Securities Management and Research, Inc. for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from the provisions of Sections 26(a)(2) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account. LINCOLN NATIONAL CONVERTIBLE SECURITIES FUND, INC., ET AL.

A conditional order has been issued on an application filed by Lincoln National Convertible Securities Fund, Inc., et al. under Sections 6(c) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order permits Lincoln National Convertible Securities Fund, Inc. and Lincoln National Income Fund, Inc. (Funds) to participate in certain joint transactions with each other and with certain affiliated persons of the Funds; and the receipt of certain fees and expenses by the Funds' investment adviser in connection with such transactions. UNITED FINANCIAL GROUP, INC.

A conditional order has been issued on an application filed by United Financial Group, Inc. under Sections 6(c) and 6(e) of the Investment Company Act, exempting applicant from all provisions of the Act, subject to certain Sections, until December 30, 1994. The exemption continues an exemption originally granted until December 30, 1990 and extended by amended orders until December 30, 1991, December 30, 1992 and December 30, 1993. (Rel. IC-19916 - December 1)

HOLDING COMPANY ACT RELEASES

NEW ENGLAND ENERGY INCORPORATED

A supplemental order has been issued authorizing New England Energy Incorporated, a fuel supply subsidiary of New England Electric System, a registered holding company, to extend its existing authority through December 31, 1995 to enter into interest rate protection agreements in respect to up to \$200 million in principal amount of its outstanding debt. (Rel. 35-25935)

DELISTING GRANTED

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration Digital Communications Associates, Inc., Common Stock, \$.10 Par Value. (Rel. 34-33264)

UNLISTED TRADING PRIVILEGES SOUGHT

Notices have been issued giving interested persons until December 22 to comment on the applications of four exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are: Cincinnati Stock Exchange - 11 issues (Rel. 34-33265) and 5 issues (Rel. 34-33269); Philadelphia Stock Exchange - 7 issues (Rel. 34-33266); Chicago Stock Exchange - 6 issues (Rel. 34-33267); and Boston Stock Exchange - 5 issues (Rel. 34-33268).
