INVESTMENT COMPANY ACT RELEASES

HOPPER SOLIDAY CORPORATION

An order has been issued exempting Hopper Soliday Corporation from all provisions of the Investment Company Act, and declaring that it has ceased to be an investment company. (Rel. IC-16198 - Dec. 31, 1987)

PRUDENTIAL-BACHE CAPITAL PARTNERS I, L.P.

An order has been issued exempting Prudential-Bache Capital Partners I, L.P. (Partnership) and Prudential-Bache Partners Inc. from all provisions of the Investment Company Act (with certain exceptions), permitting certain affiliated transactions and granting confidential treatment to certain documents in connection the Partnership's operation as an employees' securities company. (Rel. IC-16199 - Dec. 31, 1987)

OVERLAND FUNDING, INC.

An order has been issued amending a previous order dated October 19, 1986 [Rel. IC-15361] by Overland Funding, Inc. The order permits Overland to issue one or more classes of adjustable interest rate bonds secured by certain mortgage related collateral (which may include certain mortgage related collateral representing beneficial ownership interest in less than 100% of the distributions of principal or interest or both made on mortgage loans underlying such mortgage related collateral), elect one or more series of its bonds secured by certain mortgage related collateral to be treated as a REMIC, and to sell residual interest in such series. (Rel. IC-16200 - Dec. 31, 1987)

THE DREXEL BURNHAM FUND

A notice has been issued giving interested persons until January 25 to request a hearing on an application of The Drexel Burnham Fund and DBL Tax-Free Fund, Inc. for an order permitting the assessment of a contingent deferred sales load under certain circumstances. (Rel. IC-16201 - Dec. 31, 1987)

HOLDING COMPANY ACT RELEASES

THE COLUMBIA GAS SYSTEM, INC.

An order has been issued concerning a proposal by The Columbia Gas System, Inc., a registered holding company, and certain of its subsidiaries. The order authorizes through December 31, 1989 the subsidiaries' intercompany financing programs, Columbia's external short-term financing program and the continuation of the Intrasystem Money Pool. Columbia is granted an exception pursuant to Rule 50(a)(5) from the competitive bidding requirements of Rule 50. Jurisdiction is reserved over certain transactions pending completion of the record. JERSEY CENTRAL POWER & LIGHT COMPANY

An order has been issued authorizing a proposal by Jersey Central Power & Light Company (JCP&L), Metropolitan Edison Company (Met-Ed), Pennsylvania Electric Company (Penelec), subsidiaries of General Public Utilities Corporation, and their subsidiary, Saxton Nuclear Experimental Corporation, for Saxton to withdraw such amounts collected by JCP&L, Met-Ed, and Penelec from their ratepayers and deposited in trust that may be necessary to pay the costs of decommissioning and dismantling Saxton's retired nuclear facility. (Rel. 35-24542 - Dec. 23, 1987)

THE SOUTHERN COMPANY

A supplemental order has been issued releasing jurisdiction over the issuance of up to one million shares of authorized but unissued common stock of The Southern Company, a registered holding company, in connection with the Southern's Savings Plan. (Rel. 35-24544 - Dec. 28, 1987)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
