### WALLACE SLATINSKY AND LARRY A. RUPE BARRED BY DEFAULT

The Commission barred Wallace Slatinsky, of Roswell, Georgia, and Larry A. Rupe, of Chamblee, Georgia, based upon their failure to appear at the August 17, 1987 hearing In the Matter of Hereth, Orr & Jones, Inc. (HOJ), et al., which was formerly a registered broker-dealer located in Atlanta, Georgia. The Order for Proceedings alleged that respondents, while associated with HOJ in 1983, made misrepresentations of material facts and omitted to state material facts in connection with the offer and sale of Polk County Industrial Development Authority First Mortgage Health Care Facilities Revenue Bonds.
