# COMMISSION ANNOUNCEMENT'S CHANGE COMMISSION

GLEN A. PAYNE APPOINTED SENIOR COUNSEL TO THE DIRECTOR, DIVISION OF INVESTMENT MANAGEMENT

Kathryn B. McGrath, Director of the Division of Investment Management, announced that Glen A. Payne has been appointed to the newly created position of Senior Counsel to the Director. Mr. Payne joined the Commission's staff in 1973. In 1976, he was named a Special Counsel in the Division's Office of Investment Company Regulation, and promoted to Assistant Director in charge of that office in 1981. Mr. Payne received his B.A. degree, cum laude, from S.U.N.Y. at Buffalo in 1969; a J.D. from Duke University Law School in 1972; and an L.L.M. from the University of Pennsylvania Law School in 1974. #### ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST JEROME TEPPS AND MICHAEL GOLDSTEIN

The Commission instituted administrative proceedings against Jerome Tepps and Michael Goldstein, both attorneys, under Rule 2(e)(3) of the Commission's Rules of Practice. Additionally, the order temporarily suspends Tepps and Goldstein from appearing or practicing before the Commission for 30 days, based on their consents to permanent injunctions for violations of the securities laws. They may file a petition with the Commission to lift the suspension within 30 days of the effective date of the suspension. If no such petition is filed, the suspensions become permanent. (Rel. 34-25901)

### CORPORATE REORGANIZATION RELEASES

ALLEGHENY INTERNATIONAL, INC.

The Commission issued a release summarizing the positions it took in a series of briefs filed in the Chapter 11 reorganization case of Allegheny International, Inc. Creditors of Allegheny had sought unsuccessfully to enjoin an annual meeting of shareholders and a proxy contest for control of the board of directors conducted under the direction of the official equity security holders' committee. In its briefs, the Commission urged that an annual meeting or proxy contest during the plan negotiation phase of a reorganization case should not be enjoined absent a showing of "clear abuse" of the shareholders' corporate governance rights; i.e., a showing that holding the meeting would jeopardize any possibility of reorganization. The Commission further argued that the record in this case did not support a finding of clear abuse. The annual meeting took place pursuant to court order on June 20, and incumbent management reportedly retained control of the board. The litigation was thereafter terminated by stipulation. (Rel. # TRADING SUSPENSIONS

TRADING SUSPENDED IN THE SECURITIES OF CORTEZ INTERNATIONAL LTD. AND RAM INDUSTRIES, INC.

The Commission announced the single ten-day suspension of over-the-counter trading in the securities of Cortez International Ltd. and RAM Industries, Inc. for the period beginning at 9:00 a.m. (EDT) on July 21 and terminating at 11:59 p.m. (EDT) on July 30.

The Commission suspended trading in the securities of Cortez and RAM because questions have been raised about the adequacy and accuracy of publicly disseminated information concerning, among other things, the financial statements of the companies, the financial condition of the companies, and the value of their assets. ### **INVESTMENT COMPANY ACT RELEASES**

#### FREEDOM INVESTMENT TRUST

A notice has been issued giving interested persons until August 12 to request a hearing on an application filed by Freedom Investment Trust and Freedom Investment Trust II for an order amending existing exemptive orders to permit the existing and any future series of Applicants to: (a) implement a new schedule of contingent deferred sales loads (CDSL); (b) add an additional class of waiver; and (c) continue permitting certain offers of exchange in connection with the implementation of the new CDSL schedule. #### GEORGIA POWER & LIGHT COMPANY

#### EASTERN UTILITIES ASSOCIATES
