ENFORCEMENT PROCEEDINGS

IN THE MATTER OF GEORGE KOLAR

Administrative Law Judge James T. Kelly issued an initial decision on October 28 in the above-referenced matter. The Commission's Order Instituting Public Proceedings (OIP) alleged that Mr. Kolar, while employed at Dean Witter Reynolds, Inc., failed reasonably to supervise a registered representative subject to his supervision, within the meaning of Section 15(b)(4) of the Securities Exchange Act of 1934 (Exchange Act). The registered representative was alleged to have committed willful violations of Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Sections 10(b), 15(a)(1), and 15(c)(1) of the Exchange Act, as well as Commission Rules 10b-5 and 15c1-2. The administrative proceedings were instituted in order to determine whether the allegations in the OIP were true and, if so, whether remedial sanctions ought to be imposed against Mr. Kolar in the public interest.

Judge Kelly concluded that the registered representative in question committed willful violations of the securities registration and antifraud provisions; that the registered representative was subject to Mr. Kolar's supervision; and that Mr. Kolar failed reasonably to supervise him with a view to preventing the underlying violations. As sanctions, Mr. Kolar was suspended from acting in a supervisory capacity with a registered broker or dealer for six months and ordered to pay a civil penalty of \$20,000. BROKER-DEALER AND PENNY STOCK BARS IMPOSED AGAINST VINCENT IOVINE

Vincent J. Iovine has been barred from association with a broker or dealer and from participating in an offering of any penny stock. The order instituting and simultaneously settling these proceedings contained findings that Iovine had been enjoined from violations of the antifraud provisions of the federal securities laws in connection with his participation, from August 1996 through March 1997, in the manipulation of the price of American Image Motor Co. common stock. The order found that during this time, Iovine was a trader at a registered broker-dealer and that the injunction entered against him was based on his conduct in bidding for and purchasing the common stock of American Image while Iovine was participating in

a distribution of those securities. In the injunctive action, Iovine was enjoined by the United States District Court for the Southern District of New York from further violations of Section 10(b) of Securities Exchange Act of 1934 and Rule 10b-5 thereunder and Rule 101 of Regulation M. Based on the injunction, Iovine consented to be barred from participating in an offering of any penny stock and barred from association in any capacity with any broker or dealer. FORMER WALDRON PRESIDENT CERY PERLE BARRED

Cery B. Perle (Perle), the former president of the defunct broker-dealer, Waldron & Co. (Waldron), has been barred from association with any broker or dealer. The order barring Perle is the result of a public administrative proceeding instituted on August 30, 1999, which has now been settled. Perle consented to the entry of the order without admitting or denying the Commission's findings.

In the order, the Commission found that Perle had been enjoined by a United States District Court from further violations of Section 17(a) of the Securities Act and Sections 10(b) and 15(c)(1) of the Exchange Act and Rules 10b-5 and 15c1-2 thereunder, and that the District Court had also imposed \$110,000 in civil penalties against Perle. In that action, the Commission alleged that between November 25, 1997 and March 23, 1998, Perle and Waldron manipulated the stock of the California-based Internet retailer, Shopping.com, artificially raising the price of the security from its IPO price of \$9.00 to more than \$32.00 a share. The Commission further alleged that Perle manipulated Shopping.com's stock by controlling the supply and by creating artificial demand for the security. In controlling the supply, Perle, among other things, engaged in unauthorized transactions, refused to execute customer sell orders and parked stock in customer accounts. Finally, to create artificial demand, the complaint alleged that Perle issued a false and misleading press release, and while Waldron was acting as a market maker, caused the firm to raise the bid for the security without economic justification.

In a related action, the Commission cancelled Waldron's registration as a broker-dealer on March 9, 1999. (Rel. 34-41069; File No. 3-9991)

INVESTMENT COMPANY ACT RELEASES

AMERITAS VARIABLE LIFE INSURANCE CORP., ET AL.

An order has been issued pursuant to Section 26(b) of the Investment Company Act to Ameritas Variable Life Insurance Corp., Ameritas Variable Life Insurance Corp. Separate Account VA-2, Ameritas Investment Corp., and Ameritas Variable Life Insurance

Corp. Separate Account V (collectively, Applicants) approving the substitution of shares of certain registered management investment companies for shares of certain other registered management investment companies currently serving as underlying investment options for variable annuity contracts and variable life insurance policies. An order also has been issued pursuant to Section 17(b) of the Act exempting Applicants from Section 17(a) of the Act to the extent necessary to permit certain in-kind redemptions of portfolio securities in connection with the substitutions.
