### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-99-03) relating to option exercise procedures. Publication of the proposal is expected in the Federal Register during the week of April 24. (Rel. 34-42693)

The Commission approved a proposed rule change filed by Chicago Board Options Exchange (SR-CBOE-99-38) and granted accelerated approval to Amendment No. 1 thereto to amend its trade processing rules. (Rel. 34-42696)

The Commission approved a proposed rule change filed by the Philadelphia Stock Exchange (SR-PHLX-99-39) regarding specialist enhanced participation. Publication of the proposal is expected in the Federal Register during the week of April 24. (Rel. 34-42700)

The Commission approved a proposed rule change filed by the The Depository Trust Company (SR-DTC-00-04) modifying the Profile feature of DRS to incorporate the use of an electronic screen-based indemnification. Publication of the proposal is expected in the Federal Register during the week of April 24. (Rel. 34-42704)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE
