INVESTMENT COMPANY ACT

ARK FUNDS, ET AL.

An order has been issued on an application filed by ARK Funds, et al., for an order under Section 17(b) of the Investment Company Act exempting applicants from Section 17(a) of the Act. The order permits the proposed reorganizations of four series of The Govett Funds, Inc. with and into four series of ARK Funds. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-24587 – July 31)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Municipal Securities Rulemaking Board consisting of technical amendments to MSRB Rules G-8 and G-15 (SR-MSRB-00-9) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of August 7. (Rel. 34-43090)
