## DECISIONS IN ADMINISTRATIVE PROCEEDINGS

### CAPITAL DEVELOPMENT ASSOCIATES AND SEVEN UNAFFILIATED SALESMEN SANCTIONED

The Commission has suspended the broker-dealer registration of Capital Development Associates of Philadelphia for 90 days beginning May 19, 1975, after which time Capital's pending application for withdrawal of its broker-dealer registration will become effective. In the same order, Frederic James, Jr., Ralph C. Possinger, Francis J. Walsh, Benjamin Dubin, Elmer Goldberg, Samuel Mishkin and David R. Zimmerman, all of whom were salesmen for several other broker-dealers in the Philadelphia area, were suspended, also beginning May 19, 1975 from association with any broker-dealer. Walsh and James were suspended for 120 days; Possinger, Dubin, Mishkin and Zimmerman for 45 days and Goldberg for 15 days. Except for Walsh, each of the individual respondents may sell mutual fund shares during the period of his suspension. Walsh has undertaken, after completion of his suspension, not to become associated with a broker-dealer in an ownership or supervisory position, or in a capacity in which he is not properly supervised, without prior Commission approval.

The sanctions were based on findings that from August 1970 through November 1972 respondents made material misrepresentations in the offer and sale of common stock of Lomma International, Inc. The misrepresentations related to Lomma's businesses and assets, the market for its products, the dividends it would pay, the future trading market for its stock, the stock's listing on the American Stock Exchange, prospective increases in its price, and the speculative nature of an investment in Lomma.

The Commission's action was based on offers of settlement in which the respondents consented to the indicated findings and sanctions, without admitting or denying the charges against them. (Rel. 34-11411)

## TRADING SUSPENSIONS

### TRADING SUSPENDED IN INTEGRITY ENTERTAINMENT CORPORATION

The SEC has suspended over-the-counter trading in all the securities of Integrity Entertainment Corporation, of Los Angeles, California, for a ten-day period beginning on May 19 and continuing through midnight (EDT) on May 28, 1975.

The Commission initiated the suspension to allow additional time for the dissemination of news concerning an inventory theft. (Rel. 34-11429)

## COURT ENFORCEMENT ACTIONS

### ASHLAND OIL ENJOINED

The Commission announced on May 16 the entry of orders of permanent injunction against Ashland Oil, Inc., Orin E. Atkins, William R. Seaton and Clyde M. Webb in the U.S. District Court for the District of Columbia. The defendants consented to the court orders without admitting or denying the allegations of the Commission's complaint.

Under the terms of the order, defendant Ashland was enjoined from further violations of the securities laws from using corporate funds for unlawful political contributions or similar unlawful purposes; from making materially false or fictitious entries in its corporate books and records; and from establishing or maintaining any secret or unrecorded fund of corporate monies or other assets.

The Commission alleged in its complaint that defendants Ashland, Atkins, Seaton and Webb had maintained a secret fund of corporate monies in excess of \$700,000 and that monies from this fund had been used for political contributions and other purposes, a substantial portion which was unlawful.

The Commission also alleged in its complaint that during the period from 1967 to date, Ashland, Atkins and Seaton caused Ashland to disburse in excess of \$4 million in cash overseas ostensibly for business purposes without adequate accounting or auditing procedures.

The company has undertaken as part of its consent to the entry of this order to continue its ongoing investigation with respect to such payments and its corporate records and controls and to file a report of that investigation with the Commission and the Court. (SEC v. Ashland Oil, Inc., et al., U.S.D.C. District of Colo., Civ. No. 75-0794). (LR-6890)

#### WILLIAM L. O'BRYON ENJOINED

The SEC announced that on May 12 the Honorable Howard B. Turrentine, U.S. District Judge for the Southern District of California, permanently enjoined William L. O'Bryon from violations of the antifraud provisions of the securities laws in connection with a fraudulent scheme to assist U.S. Financial, Inc. (USF) and its former management in the overstatement of revenues and profits of the company for the years 1970-1972. O'Bryon consented to the charges without admitting or denying the allegations. The court order also requires O'Bryon to tender to USF all his interest in certain property and in a certain escrow fund established from the sale of another property. (SEC v. U.S. Financial, Inc., et al., S.D. Cal 74 Civ. 92-T). (LR-6889)

#### SEVEN INDICTED IN NEW YORK

The New York Regional Office announced the following convictions and sentences in the case of U.S. v. Rubinson, et al: (a) Sidney Stein sentenced to 10 years in jail and fined \$20,000; and Philip Kaye sentenced to a term of one year and one day. Norman Rubinson and Albert Feiffer were found guilty of conspiracy to violate and substantive violations of the securities laws; Lawrence Levine was found guilty of conspiracy to violate the securities laws; and William K. Chester and Edgar Reynolds were found guilty of violations of the registration provisions of the securities laws.

The defendants were found guilty on March 23, 1975 after a nine week jury trial before the Honorable Constance Baker Motley. Both Stein and Kaye pled guilty before trial to conspiracy to violate and substantive violations of the securities laws. The defendants were indicted on June 4, 1974 wherein they were charged with the commission of various crimes in connection with transactions in the common stock of Stern-Haskell, Inc. (SEC v. Rubinson, et al., 74 Cr. 573 S.D.N.Y.). (LR-6891)

#### ROBERT ALDEN RHOADS, OTHERS INDICTED

The Los Angeles Regional Office announced that on May 13 a federal grand jury in Los Angeles, California, returned four separate indictments charging eight individuals with multiple charges, including violations of the federal filing of a false tax return, all arising out of alleged fraudulent activities relating to the Shamrock Fund, a small open-end and diversified mutual fund that was based in Westlake Village, California. Charged were: Robert Alden Rhoads, of Mission Viejo, California, former manager of the Shamrock Fund; Hunter Brooks Brashier, of Woodland Hills, California; John Michael Coughlan, Sr., of Los Angeles, California; Nicholas G. Snyder, of Houston, Texas, president of Kardar Canadian Oils, Ltd., an oil company in Houston; Duane Smith Jensen, of Salt Lake City, Utah, former president of Transamerican Securities, Inc., a Salt Lake City brokerage firm; Jerry V. Strand, a Salt Lake City, Utah attorney; G. Alfred Roensch, a San Francisco, California attorney; and Leo L. Lamb, of Orinda, California.

The indictments allege that Rhoads, as Fund manager, accepted secret pay backs from the other defendants for causing the Shamrock Fund to purchase securities which they owned or controlled. The indictments allege that Rhoads caused the Fund to purchase approximately \$750,000 of securities and in turn received approximately \$200,000 either directly or through Lincoln Management Company, the Fund's former investment adviser, from the other defendants. (U.S. v. Robert Alden Rhoads, et al., C.D. CA Criminal Action No. 75-737, 75-738, 75-739, 75-740). (LR-6892)
