## ADMINISTRATIVE PROCEEDINGS

---

### JAMES J. KEEGAN CITED

The Commission announced that public administrative proceedings have been ordered against James J. Keegan, Frank W. Humpherys and Vaughn H. Shaw, all of Denver, Colorado. The Commission's Order for Proceedings alleges that Keegan aided and abetted a registered broker-dealer to violate Section 15(b), 15(c)(3) and 17(a) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 15b3-1, 15c3-1, 15c3-3, 17a-3 and 17a-5 thereunder; that Humpherys aided and abetted a broker-dealer to violate Section 17(a) of the Exchange Act and Rule 17a-3 thereunder; and that Shaw aided and abetted a broker-dealer to violate Section 15(c)(2) of the Exchange Act and Rule 15c2-4 thereunder. The Order for Proceedings also alleges that Keegan failed to reasonably supervise persons subject to his supervision with a view toward preventing the above violations.

A hearing will be scheduled to take evidence on the staff's allegations and to afford respondents an opportunity to present any defenses thereto. (Rel. 34-19872)

### TIARA CORPORATION, OTHERS ENJOINED

The Seattle Regional Office announced that on June 14 the U.S. District Court in Boise, Idaho granted the Commission a permanent injunction against Tiara Corporation (an Idaho corporation) and National Funding Corporation (a California corporation), both of Burley, Idaho; Floyd Calvin Anglin of Las Vegas, Nevada; and Claude T. Rowe of Westminister, California, based on the Commission's motion for partial summary judgment with respect to alleged violations of Section 13 of the Securities Exchange Act of 1934 and related rules. ### NOTICE OF PROPOSED RULE CHANGES

The following have filed proposed rule changes under Rule 19b-4: New York Stock Exchange - (SR-NYSE-83-18) to modify NYSE Rule 345 relating to employment standards of members and member organizations (Rel. 34-19893); and (SR-NYSE-83-21) that would facilitate the implementation and operation of certain enhancements to the Exchange's Designated Order Turnaround and Limit Order Systems in order to ensure timely reporting of executions through these systems (Rel. 34-19897). Publication of the above two proposals are expected to be made in the Federal Register during the week of June 27. Municipal Securities Rulemaking Board - (Sr-MSRB-83-5) to amend the requirements of MSRB Rule G-15 on disclosure of yield calculations on customer confirmations for transactions effected on a dollar basis (Rel. 34-19894); and (SR-MSRB-83-6) to require disclosure on confirmations if interest will be paid on other than a semi-annual basis (Rel. 34-19895).
