### FINDINGS AND SANCTIONS ENTERED RE INTERNATIONAL SECURITIES, INC.

The Commission announced the entry of Findings and Order Imposing Remedial Sanctions under Sections 15(d) and 19(h) of the Securities Exchange Act of 1934, and Section 14(b) of the Securities Investor Protection Act in the Matter of International Securities, Inc. (ISI), a registered broker-dealer located in Denver, Colorado. The Order and Findings were entered under provisions in 17 CFR §§ 201.6(e) and 201.7(b) and (e) for Default Judgment based on ISI's failure to file an Answer to the Order or enter an appearance at the hearing in this matter which was held on August 9, 1983 in Denver.

Findings were entered that ISI wilfully violated Sections 7(c), 15(c), 17(a) and 10(b) of the Exchange Act, Rules 15c2-4, 15c3-1, 17a-3, 17a-4, 17a-5, 17a-11 and 10b-5, and Regulation T by the Board of Governors of the Federal Reserve System by continuing to conduct business without sufficient net capital, failing to properly keep and maintain accurate books and records, failing to promptly escrow monies obtained in payment for a new issue and by filing false Regulation T extension requests. ISI's registration as a broker-dealer was revoked. (Rel. 34-20119)

### DATE SET FOR SUSPENSION OF JAMES E. RYAN

In April 1982, the Commission sanctioned James E. Ryan of Seattle, a brokerage firm vice president. The Commission found that, during the period October 1978 through March 1979, Ryan unlawfully sold unregistered stock, charged customers excessive markups in the sale of various securities, was responsible for his firm's failure to keep certain records accurate, and, in a few instances, deliberately falsified those records. The Commission suspended Ryan from association with any broker or dealer for a period of three months.

Ryan's suspension was stayed pending appeal. The Court of Appeals for the Ninth Circuit recently affirmed the Commission's order. The Commission has accordingly made Ryan's suspension effective September 19, 1983. (Rel. 34-20130)

## CRIMINAL PROCEEDINGS

### WALKER AND ATKINSON SENTENCED

The Seattle Regional Office and the Corporation Division of the State of Oregon jointly announced that on August 18 Marion County Circuit Court Judge Robert McConville sentenced Donald Lee Walker and Donald Junior Atkinson to five and three years in prison, respectively, on one count each of securities fraud, sale of unregistered securities and filing a false statement with the State Corporation Commission for a total of 15 years for Walker and nine years for Atkinson. The sentences were suspended on the condition that the defendants jointly make restitution of \$2,226,565.99 for securities fraud, \$680,693.34 for the sale of unregistered securities and pay fines of \$5,000 (Walker) and \$2,500 (Atkinson) for the filing of false documents with the State Commissioner and on the condition that Walker serve 180 days and Atkinson serve 90 days in the Marion County jail. ### NOTICE OF PROPOSED RULE CHANGES

The following have filed proposed rule changes under Rule 19b-4: The American Stock Exchange, Inc. (SR-Amex-83-19) to amend Amex Rule 343 to modify the qualification requirements for supervisory analyst candidates. (Rel. 34-20150); the National Securities Clearing Corporation (SR-NSCC-83-11) that would enable NSCC to invest all or some of the cash portion of member's clearing fund contributions in certificates of deposit of banks approved by the Federal Deposit Insurance Corporation and selected by NSCC. (Rel. 34-20152); and The Municipal Securities Rulemaking Board (SR-MSRB-83-12) to amend MSRB Rules G-12 and G-15 regarding necessary disclosure on inter-dealer confirmations and customer confirmations for zero coupon, compound interest and multiplier securities. ### EFFECTIVENESS OF PROPOSED RULE CHANGE

A rule change filed by the Options Clearing Corporation under Rule 19b-4 (SR-OCC-83-19) has become effective in accordance with Section 19(b)(3)(A) of the Securities

Exchange Act of 1934. The proposed rule change clarifies that the entities and persons subject to the indemnification provisions of Section 28(f) of OCC's Restated Participant Exchange Agreement are identical with those entities and persons in Section 2(g) of the Agreement (for example, the term "Participating Exchange" in Section 28(f) would be interpreted to include a Participating Exchange and its governors, directors and officers and each person who controls such an Exchange within the meaning of Section 20 of the Act or Section 15 of the Securities Act of 1933).
