## ENFORCEMENT PROCEEDINGS

---

### AHMED MOHAMED SOLIMAN

Judge Brenda P. Murray ordered revocation of the investment adviser registration of Ahmed Mohamed Soliman of Baton Rouge, Louisiana and barred Mr. Soliman from being associated with any broker, dealer or investment adviser. Mr. Soliman's investment adviser registration became effective in July 1992. Judge Murray found that Mr. Mohamed, who A.G. Edwards terminated as a registered representative after he pled guilty to submitting false documents to the Internal Revenue Service, willfully violated the record keeping requirements of the Advisers Act and exhibited such untruthfulness about material matters that a severe sanction was required in the public interest. ## SELF-REGULATORY ORGANIZATIONS

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-94-5) to provide notice of an increase in the application fee for new firms, other than self-clearing or introducing firms, from \$1,500 to \$3,000. The proposed rule change became effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of January 31. (Rel. 34-33533)
