## RULES AND RELATED MATTERS

---

### ADOPTION OF AMENDMENTS TO SIMPLIFY THE REGISTRATION AND REPORTING REQUIREMENTS FOR FOREIGN ISSUERS AND ADOPTION OF RULE 135C AND PROPOSAL OF AMENDMENTS TO STREAMLINE FINANCIAL STATEMENT REQUIREMENTS

The Commission adopted amendments to Form F-3, Rule 139 and other forms and rules, and adopted Rule 135c. The amendments expand the universe of foreign issuers eligible to use short-form and shelf registration under the Securities Act; streamline financial statement reconciliation and financial statement requirements for foreign issuers; provide a new safe harbor for company announcements regarding exempt offerings or unregistered offshore offerings; and expand safe harbor protection for certain analyst reports. Securities Act Release No. 7053 (April 19, 1994).

The Commission also proposed for comment amendments to Regulation S-X and Form 20-F. The proposed amendments streamline (1) financial statement requirements for U.S. issuers relating to significant foreign equity investees and business acquisitions and financial schedule requirements for all issuers (Securities Act Release No. 7055; File No. 87-12-94); (2) financial statement requirements relating to foreign issuer reporting currency and operations in hyperinflationary economies (Securities Act Release No. 7054; File No. 87-11-94); and (3) financial statement requirements for foreign issuers entering into business combinations (Securities Act Release No. 7056; File No. 87-13-94). Comments on the proposals should be submitted in triplicate to Jonathan G. Katz, Secretary, Securities and Exchange Commission, 450 5th Street, N.W., Stop 6-9, Washington, D.C. 20549 on or before 90 days from date of publication in the Federal Register and should reference the appropriate file number.

## **REVIEW OF ANTIMANIPULATION REGULATION OF SECURITIES OFFERINGS**

On April 19, the Commission authorized the publication of a concept release soliciting comment on the Commission's rules governing manipulative conduct during securities offerings, particularly Rules 10b-6, 10b-7, 10b-8, and 10b-21 under the Securities Exchange Act of 1934. The Commission is seeking comment on whether and what form of regulation of trading practices during offerings is necessary and appropriate. Several proposed alternative regulatory structures are discussed. The objective of this concept release is simplification of antimanipulation regulation, in light of recent changes in the securities markets and distribution practices. ## **ENFORCEMENT PROCEEDINGS**

### **PATRICIA JOHNSON SUSPENDED**

Administrative Law Judge Glenn Robert Lawrence ordered that Patricia A. Johnson be suspended from acting in any supervisory capacity with any broker or dealer for a period of six months. Judge Lawrence found that Ms. Johnson, the manager of PaineWebber, Inc., Beverly Hills branch office, failed to effectively and reasonably supervise David Zetterstrom, a registered representative in the branch. Zetterstrom misappropriated \$114,500 from the accounts of 3 customers after Johnson was on notice from PaineWebber auditors of deficiencies in account withdrawal documentation. ## **INVESTMENT COMPANY ACT RELEASES**

### **THE MEXICO FUND, INC., ET AL.**

A conditional order has been issued under Section 10(f) of the Investment Company Act on an application filed by The Mexico Fund, Inc., et al. The order permits applicant to purchase securities in public offerings in Mexico in which a company that has the same director or directors as an applicant, or a company controlled by, under common control, or controlling such company, participates as a principal underwriter. **ACQUISITIONS OF SECURITIES**

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
