ENFORCEMENT PROCEEDINGS

RULE 2(e) PROCEEDINGS INSTITUTED AGAINST BARRY SIVESTAIN, CPA, ET AL.

The Commission has instituted public Rule 2(e) administrative proceedings against Barry H. Silvestain, CPA; Lawrence L. Greenberg, CPA; Bennie Silvestain, CPA; and Wenner, Silvestain & Company, charging them with improper professional conduct during the audit of the financial statements of U.S. Mint, Inc. for six-month period ended February 28, 1990.

The Order for Proceedings alleges that respondents provided an unqualified audit report on materially false and misleading financial statements that were issued by U.S. Mint, Inc. in order to show net tangible assets in excess of \$2 million, thereby exempting the company's securities from the cold call rule set forth in Exchange Act Rule 15b2-6. The auditors are charged with violating generally accepted auditing standards by, among other things, failing to plan or perform appropriate audit procedures; failing to exercise the requisite level of due professional care; failing to properly document their procedures in the working papers; failing to obtain sufficient competent evidential matter

and violating the reporting standards by failing to require footnote disclosure of a material contingency and improperly opining that the financial statements were prepared in accordance with generally accepted accounting principals when they were not. (Rel. 34-34190; AAE Rel. 567)

CEASE-AND-DESIST PROCEEDINGS INSTITUTED AGAINST MARK BOGOSIAN AND MARK DENEBEIM

The Commission today announced the entry on June 9 of an Order Instituting Public Administrative Proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) finding that Mark Bogosian (Bogosian) and Mark Denebeim (Denebeim) each violated Section 10(b) of the Exchange Act and Rule 10b-21 thereunder [17 C.F.R. § 240.10b-21, originally adopted as 17 C.F.R. § 240.10b-21(T)]. Simultaneous with the institution of these proceedings, the Commission accepted their Offers of Settlement in which each, without admitting or denying the findings, consented to the entry of a Cease and Desist Order and agreed to the disgorgement of illegal profits.

The Commission found that, Bogosian, with respect to three public offerings, and Denebeim, with respect to two public offerings, sold securities short during the period after the registration statement was filed, but before the offered shares became publicly available, and subsequently covered the short positions with securities purchased in the public offerings, violating Section 10(b) of the Exchange Act and Rule 10b-21 thereunder. The Commission further found that Bogosian and Denebeim realized illegal profits and ordered them to disgorge profits of approximately \$3,900 and \$1,200, respectively. (Rel. 34-34191)

PRELIMINARY INJUNCTION ENTERED AGAINST PARKERSBURG WIRELESS LLC AND OTHER DEFENDANTS

The Commission announced that on June 15 the United States District Court for the District of Columbia entered a Preliminary Injunction and Order Freezing Certain Assets and Granting Other Relief against Parkersburg Wireless LLC, Michelle A. Gerstner, Rodney Bonvicino, John C. Trimpin, George N. Riggle, Jr., PX Marketing, Inc., Madcap Services, Inc., Infotech Group, Inc., Multistate Communications, Inc., Alternative Management, Inc., D.R. Williams Consulting, Inc., Capital Resource Management, Inc., Touch Access Technologies, Inc., and Cablefree Communications, Inc., temporarily restraining and enjoining the defendants from violations of Section 5(a) and (c) of the Securities Act of 1933; temporarily restraining and enjoining defendants PWLLC, Gerstner, Bonvicino, Riggle, and Infotech from violating Section 17(a) of the Securities Act and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder; and temporarily restraining and defendants PX Marketing, Madcap Services, Infotech, Multistate, Alternative, D.R. Williams, Capital Resource, Touch Access, and Cablefree from violating Section 15(a) of the Exchange Act.

In addition, the Court continued a temporary freeze on the defendants' assets, and restrained the defendants, pending the resolution of the Commission's action on the merits, from destroying documents relating to any transaction described in the Commission's complaint. INVESTMENT COMPANY ACT RELEASES

MCDONALD U.S. GOVERNMENT MONEY MARKET FUND, INC. MCDONALD MONEY MARKET FUND, INC.

NATIONAL HOME LIFE ASSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until July 11 to request a hearing on an application filed by National Home Life Assurance Company, National Home Life Assurance Company Separate Account V (Separate Account) and Capital Values Securities Corporation for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order would provide exemptions to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain flexible premium variable annuity contracts and any materially similar contracts offered in the future by the Separate Account.
