## ENFORCEMENT PROCEEDINGS

---

### C. DANIEL MCCLAIN ORDERED TO PAY DISGORGEMENT AND CIVIL PENALTIES

The Commission announced that on August 10 the Honorable Orinda D. Evans, U.S. District Judge for the Northern District of Georgia, Atlanta Division, ordered defendant C. Daniel McClain (McClain) to pay \$113,689 in civil penalties for his violations of the federal securities laws. Previously, on June 14, 1994, McClain was ordered to disgorge \$113,689, the amount of his pecuniary gain from the fraudulent scheme described below. On May 19, 1993, McClain consented to the entry of a permanent injunction against him.

The Commission's complaint alleged that McClain engaged in the fraudulent sale of securities of International Trading, Inc. (ITI). ITI is a defendant in a pending suit by the Commission and is the subject of a permanent injunction in that case. ITI offering materials distributed by McClain promised investors that for each share of ITI stock they purchased for \$100, they would receive a warrant to be redeemed for \$200,000. The exorbitant proceeds were purported to be paid from a fortune accumulated by a deceased European "financier" and claimed to be in excess of \$1 trillion. The complaint alleges that the purported fortune does not exist. [SEC v. C. Daniel McClain, Civil Action No. 1:93-CV-782-ODE, ND Ga.] (LR-14194)

## INVESTMENT COMPANY ACT RELEASES

---

### DELAWARE GROUP TREND FUND, INC., ET AL.

A notice has been issued giving interested persons until September 2 to request a hearing on an application filed by Delaware Group Trend Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule

22c-1 thereunder. The order would permit certain investment companies to issue multiple classes of shares representing interests in the same portfolio of securities, and to assess a contingent deferred sales charge (CDSC) on redemptions of shares. The order would supersede two prior orders by permitting the investment companies to issue additional classes and consolidating the CDSC arrangement for the investment companies. (Rel. ##### THE COLUMBIA GAS SYSTEM, INC.

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
