ENFORCEMENT PROCEEDINGS

ORDER AGAINST CHARLES MARINI

On October 13, the Commission issued an Order in connection with administrative proceedings that it instituted on August 12, 1994 against Charles F. Marini (Marini). Marini consented to the issuance of the Order without admitting or denying its findings. The Order is related to the activities of Transmark USA, Inc. (Transmark) and its primary subsidiary, Guarantee Security Life Insurance Company (GSL), which were the subject of the Commission's civil injunctive action against Transmark, Mark C. Sanford and William B. Blackburn (SEC v. Transmark USA, Inc. et al., No. 94-569-CIV-J-16, M.D. Fla. June 13, 1994, Lit. Rel. No. 14124).

The Order finds that Marini caused Transmark to violate the antifraud provisions of the federal securities laws. In addition, it finds that Marini falsified, or caused to be falsified, books and records in violation of Commission Rule 13b2-1. (Rel. 34-34836; AAE Rel. 616)

TEMPORARY RESTRAINING ORDER ISSUED AGAINST JOHN HICKEY, MAMIE TANG AND CONTINENTAL CAPITAL FINANCIAL GROUP, INC.

The Commission today announced that on September 19 the Honorable Fern M. Smith of the United States District Court for the Northern District of California granted a Temporary Restraining Order (Order) against Defendants John A. Hickey (Hickey), Mamie Tang (Tang), Continental Capital Financial Group, Inc. (CCFG) and others.

The Commission's complaint alleges that from July 1992 through July 1994, Hickey, Tang and CCFG offered and sold unregistered securities in the form of limited partnership interests to the general public, obtaining approximately \$15,000,000 from 400 investors via the securities offering, and that Hickey, Tang and CCFG and their agents

have made numerous misrepresentations and omissions concerning the securities that they have offered and sold. In particular, the defendants are alleged to have misrepresented the value of real estate purportedly securing the investment, and overstated their personal net worth in connection with personal guarantees they provided. In addition, the complaint alleges that the defendants failed to use investors funds for the purposes for which they were purportedly raised and diverted funds to their own use.

The Order temporarily restrains and enjoins the defendants from violating, directly or indirectly, Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder. The Order further freezes the assets of Hickey, Tang, CCFG and certain affiliated entities, temporarily enjoins the defendants from transferring assets or destroying records, appoints a temporary receiver for CCFG, and grants the Commission's request for expedited discovery. The Order also orders the defendants to show cause why a preliminary injunction should not be granted. [SEC v. John A. INVESTMENT COMPANY ACT RELEASES

THE AMERICAN FRANKLIN LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting The American Franklin Life Insurance Company, Separate Account VUL-2 of The American Franklin Life Insurance Company and Franklin Financial Services Corporation (Applicants) from Section 27(a)(3) of the Act and Rule 6e-3(T)(b)(13)(ii) thereunder. The order provides exemptions to the extent necessary to permit Applicants to issue flexible premium variable life insurance contracts that provide for a front-end sales load on premium payments made in any given year up to a maximum amount and no sales charge on premiums in excess of that amount.
