RULES AND RELATED MATTERS

FINAL RULEMAKING

The Commission has adopted amendments to Rule 3a12-8 under the Securities Exchange Act of 1934 which designates the debt obligations of the Kingdom of Spain as exempted securities, solely for the purpose of futures trading thereon. Publication of the order is expected in the Federal Register during the week of October 31. (Rel. 34-34902)

ENFORCEMENT PROCEEDINGS

CEASE AND DESIST ORDER ENTERED AGAINST DAVID CHANDLER

The Commission announced the issuance of an Order pursuant to Section 21C of the Securities Exchange Act against David L. Chandler (Chandler), requiring Chandler to permanently cease and desist from committing or causing any violation of, or any future violation of, Sections 13(d) and 16(a) of the Exchange Act and Rules 13d-1, 13d-2, 16a-2 and 16a-3 promulgated thereunder. Chandler, without admitting or denying the allegations in the Commission's Order, consented to its entry. Chandler is the Chairman of the Board of Directors and Chief Executive Officer of Redlaw Industries, Inc. (Redlaw) and Johnston Industries, Inc. (Johnston). The Order finds that for periods up to approximately three years and three months Chandler failed to file a Schedule 13D and five amendments for his ownership of Redlaw stock, and that for periods up to fifteen years Chandler failed to file a Form 3 and twelve Forms 4 and 5 for transactions in Redlaw involving a combined value of \$2,298,448. Chandler also failed for periods up to approximately thirteen years to file a Form 3 and four Forms 4 for transactions in Johnston involving a combined value of \$671,330. Redlaw's shares are traded on the American Stock Exchange and Johnston's shares are traded on the New York Stock Exchange. (Rel. 34-34904)

JOHN FAULS III SENTENCED

The Securities and Exchange Commission and the United States Attorney for the Northern District of Illinois had previously announced that on May 3, 1994, John L. Fauls III had been found guilty of securities fraud, mail fraud, bribing a pension fund official, and racketeering

following a two week jury trial. Faults, a former stockbroker, and Robert Burstein, a pension fund manager and a director of a bank, engaged in a scheme to rig securities transactions, executed through Faults, to ensure a profit to the bank of which Burstein was a director, at the expense of the pension fund. Burstein had previously entered a guilty plea. The scheme involved interpositioning the bank between the fund and the market and also allocating profitable trades to the bank instead of the pension fund. On October 24, Judge Zagel of the United States District Court for the Northern District of Illinois sentenced Faults to 57 months in prison followed by three years supervised release and 2,000 hours of community service. Faults was also ordered to make restitution in the amount of \$3.32 million and ordered to forfeit \$3.32 million. The Midwest Regional Office participated in the criminal investigation. [SEC v. John L. Faults III and Robert Burnstein, Crim. Action No. 93 CR 80, N.D. ILL] (LR-14306)

THOMAS BANDYK ENJOINED

The Commission announced that on August 1, 1994, the United States District Court for the Western District of Michigan entered an order which permanently enjoins Thomas F. Bandyk (Bandyk), a resident of Grand Rapids, Michigan, from further violations of the antifraud provisions of the federal securities laws. Bandyk consented to the entry of the order without admitting or denying the allegations contained in the complaint.

According to the complaint, from at least September 1989 to approximately May 1990, while working as a registered representative at the Grand Rapids, Michigan branch office of a broker-dealer registered with the Commission, Bandyk conducted excessive, unsuitable, and unauthorized trading in his customers' accounts. In addition, according to the complaint, Bandyk misrepresented and failed to disclose several material facts to his customers, relating to, among other things, the significance of margin calls and the risks associated with trading on margin. SELF-REGULATORY ORGANIZATIONS

NOTICE OF FILING PROPOSED RULE CHANGE

The Stock Clearing Corporation of Philadelphia has filed a proposed rule change (SR-SCCP-94-05) under Section 19(b) of the Exchange Act. The rule change amends SCCP Rule 2, Section 1 to require each participant to execute a Participant's Agreement. Publication of the proposal is expected in the Federal Register during the week of October 31. (Rel. 34-34886)

ORDER APPROVING PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-CBOE-94-30) filed by the Chicago Board Options Exchange pursuant to Rule 19b-4 under the Securities Exchange Act which amends CBOE Rule 9.8, Supervision of Accounts, to enable members' supervisory offices to maintain certain customer account information at off-site locations as long as the records are readily accessible and promptly retrievable. Publication of the order is expected in the Federal Register during the week of November 7. (Rel. 34-34899)

The Commission approved a proposed rule change submitted under Rule 19b-4 by the New York Stock Exchange (SR-NYSE-94-30) to permanently approve revisions to the Exchange's allocation policy and procedure. (Rel. 34-34906)

The Commission approved a proposed rule change (SR-PHLX-94-35) filed by the Philadelphia Stock Exchange pursuant to Rule 19b-4 under the Securities Exchange Act which amends PHLX Rule 1025, Supervision of Accounts, to allow member organizations to maintain customer information and account statements off-site rather than at the principal supervisory office, as long as the records are readily accessible and promptly retrievable. Publication of the order is expected to appear in the Federal Register during the week of November 7. (Rel. 34-34909)

NOTICE OF FILING AND EFFECTIVENESS OF PROPOSED RULE CHANGE

The Midwest Clearing Corporation and Midwest Securities Trust Company have filed proposed rule changes (SR-MCC-94-10 and SR-MSTC-94-11) which became effective under Section 19(b)(3)(A)(ii) of the Securities Exchange Act. The new rule provisions change the name of the MST Communications System to the MST Link. The changes also merge the services and fees under the MSTC Link Service into the general schedule of services and fees for the MST Link Service, and provide for a \$25 fee for each terminal ID after the first terminal ID. (Rel. 34-34895)

ORDER GRANTING ACCELERATED APPROVAL OF PROPOSED RULE CHANGES, AND AMENDMENTS.

The Commission has granted accelerated approval to proposed rule changes by the New York Stock Exchange (SR-NYSE-94-33), and Amendment No. 1 thereto, and the Philadelphia Stock Exchange (SR-PHLX-94-44) and Amendment No. 1 thereto, and is publishing notice of, and is granting accelerated approval to, a proposed rule change by the American Stock Exchange (SR-AMEX-94-40) pursuant to Rule 19b-4 under the Securities Exchange Act relating to an extension of certain market-wide circuit breaker provisions. Publication of the approval order is expected in the Federal Register during the week of November 7. (Rel. 34-34900)
