INVESTMENT COMPANY ACT RELEASES

NATIONWIDE VARIABLE ACCOUNT-6, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Nationwide Life Insurance Company, Nationwide Variable Account-6 (Account) and Financial Horizons Securities Corporation from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Account under certain variable annuity contracts. (Rel. IC-20708 - November 16)

NATIONWIDE VARIABLE ACCOUNT-7, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Nationwide Life Insurance Company, Nationwide Variable Account-7 (Account) and Fidelity Investments Institutional Services Company, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Account under certain variable annuity contracts. (Rel. IC-20709 - November 16)

CONNECTICUT MUTUAL INVESTMENT ACCOUNTS, INC., ET AL.

A notice has been issued giving interested persons until December 12 to request a hearing on an application filed by Connecticut Mutual Investment Accounts, Inc., et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order would permit applicants to issue multiple classes of shares representing interests in the same portfolio of securities, assess a contingent deferred sales load (CDSL) on certain redemptions of shares, and waive the CDSL in certain instances.
