U.S. SECURITIES AND EXCHANGE COMMISSION

CIVIL PROCEEDINGS

DAVID E. HOUGE AND MICHAEL C. CAMERON ENJOINED

The Chicago Regional Office announced that on August 5 U.S. District Judge Scott Reed, Eastern District of Kentucky, entered orders of permanent injunction against David E. Houge and Michael C. Cameron. Both defendants, without admitting or denying the allegations in the Commission's complaint, consented to the permanent injunctions which enjoined them from violating registration and antifraud provisions of the securities laws. Additionally, Houge was enjoined from violating certain reporting provisions. Each defendant also submitted a court-ordered accounting reflecting the proceeds received from certain sales of common stock issued by Coal Technology Corporation (CTC).

The July 31, 1985 complaint alleged that the defendants violated registration and antifraud provisions of the securities laws in the offer and sale of securities issued by CTC. The fraudulent conduct occurred at different times from March 1981 through January 1984 and included the dissemination of false and misleading publicity concerning CTC's business activities and projections of revenue and profit.

The other defendants named in the complaint previously consented to final judgments of permanent injunction. (SEC v. Daivd E. Houge, et al., EDKY, Civil No. 85-305). (LR-11202)

INVESTMENT COMPANY ACT RELEASES

LYONS FUNDING CORPORATION

A notice has been issued giving interested persons until September 8 to request a hearing on an application by Lyons Funding Corporation for an order exempting it from all provisions of the Act to permit its proposed issuance of mortgage related securities. (Rel. IC-15259 - August 15)

COWEN INCOME & GROWTH FUND, INC.

PRATT STREET VENTURES III LIMITED PARTNERSHIP

A notice has been issued giving interested persons until September 12 to request a hearing on an application filed by Pratt Street Ventures III Limited Partnership, a Maryland limited partnership, for an order exempting it from all provisions of the Investment Company Act, and declaring that it has ceased to be an investment company as defined in the Act. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Depository Trust Company has become immediately effective. The proposal (SR-DTC-86-8) clarifies that DTC's lottery system is used to apportion advance refunds of debt securities. (Rel. 34-23543)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by The American Stock Exchange (SR-Amex-86-16) to operate AUTO-EX, its automatic execution system, for selected orders in the Major Market Index options on a permanent basis. (Rel. 34-23544)

NOTICE OF PROPOSED RULE CHANGE

The Chicago Board Options Exchange filed a proposed rule change under Rule 19b-4 (SR-CBOE-86-29) concerning order size eligibility for its proposed Retail Automatic Execution System pilot for Standard and Poor's 500 Index options. Publication of the proposal is expected to be made in the Federal Register during the week of August 25. (Rel. 34-23545)
