## **ADMINISTRATIVE PROCEEDINGS**

NASD ACTION AGAINST RICHARD A. BRENNAN AFFIRMED

The Commission affirmed sanctions imposed by the NASD on Richard A. Brennan, of Delray Beach, Florida, former syndicate manager of First Florida Securities, Inc., an NASD member firm. The NASD censured Brennan and fined him \$1,500.

In 1981, First Florida was a member of the selling group for an offering of Duquesne Light Company common stock at a price of 12-3/8 per share. The Commission found, as had the NASD, that Brennan violated NASD rules by selling his firm's entire allotment of Duquesne stock to a customer at a price of 12-1/8 prior to the close of the offering. ### CIVIL PROCEEDINGS

ENERGY RESERVE, INC. ENJOINED

The Commission announced that on November 14 the U.S. District Court for the District of Columbia entered a Final Judgment of Permanent Injunction against Energy Reserve, Inc. of Phoenix, Arizona. The Judgment restrained and enjoined Energy from failing to file timely and in proper form accurate and complete periodic reports and Notifications of Late Filing.

In its June 17 complaint, the Commission alleged that Energy, as part of a continuing course of violative conduct extending over several years, failed to file its Annual Reports on Form 10-K for its fiscal years ended December 31, 1986 and 1985, respectively, in that its 1985 Annual Report lacked audited financial statements; failed to file its Quarterly Report on Form 10-Q for its fiscal quarter ended March 31, 1986; and filed late four Annual and eight Quarterly Reports. Energy, consenting to the Court's Judgment, admitted that it had filed late six Annual and nine Quarterly Reports, including two incomplete Annual Reports, and failed to file 13 Notifications of Late Filing. (SEC v. Energy Reserve, Inc., USDC DC, Civil Action No. 86-1671). (LR-11291)

### **CRIMINAL PROCEEDINGS**

RICHARD HIRSCHFELD SENTENCED IN CRIMINAL CONTEMPT ACTION

The New York Regional Office announced that on November 14 Richard Hirschfeld was sentenced by U.S. District Judge Robert J. Ward, Southern District of New York, in a criminal contempt action. Judge Ward suspended the sentenced and placed Hirschfeld on probation for three years with the special condition that Hirschfeld contribute 300 hours to a community service program during the probationary period.

This criminal action arose from mthe Commission's prior civil action against Hirschfeld. In November 1984 in SEC v. Champion Sports Management, Inc. and Richard Hirschfeld, 599 F. Supp. 527 (SDNY 1984) aff'd, No. 84-6358 (2nd Cir. April 26, 1985), Hirschfeld was permanently enjoined from violations of antifraud provisions of the securities laws.

On June 26 the Commission's application for an Order to Show Cause was granted, charging that Hirschfeld had wilfully violated the Champion injunction and an earlier Court bench order. On September 29 Hirschfeld pled guilty to failing to disclose the Champion injunction in the 1984 and 1985 Annual Reports filed with the Commission by Hirsch-Chemie Limited, a public company located in Virginia of which he was an officer and director. (U.S. ex rel. SEC v. Richard Hirschfeld, 86 Cr. Misc. 1 [page 24], RJW, SDNY, November 14, 1986). (LR-11289)
