ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST BARRY L. KING, OTHERS

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 and the Investment Advisers Act of 1940 against Barry L. King and Marc D. Shiner, registered investment advisers, and Wellesley Financial Management Services, Inc., a registered broker-dealer, all of Wellesley, Massachusetts. The Commission found that King and Shiner, president and treasurer, respectively, of Wellesley Financial, were convicted of insurance fraud, larceny, and attempted larceny for submitting false receipts to insurance companies in a scheme to collect reimbursement for property claimed to have been stolen from their homes. It further found that Wellesley Financial, jointly owned by King and Shiner, failed promptly to amend its Form BD registration to reflect the felony convictions.

Simultaneously, the Commission accepted Offers of Settlement in which King, Shiner and Wellesley Financial consented to an Order making findings and: (1) revoking King's and Shiner's investment adviser registrations; (2) barring King and Shiner from association with any broker or dealer, investment company, investment adviser, or municipal securities dealer, with the proviso that after three and five years, respectively, they may reapply for association with a broker or dealer in a non-supervisory, nonproprietary capacity; and (3) revoking Wellesley Financial's registration. MONONGAHELA POWER COMPANY

An order has been issued authorizing Monongahela Power Company), The Potomac Edison Company, and West Penn Power Company (collectively, Companies), subsidiaries of Allegheny Power System, Inc., to issue and sell short-term promissory notes to banks and dealers in commercial paper from time to time through June 30, 1988 in aggregate principal amounts not exceeding \$75 million, \$76 million and \$132 million at any one time outstanding for Monongahela, Potomac Edison and West Penn, respectively. The proposed issuance and sale of notes by each Company to dealers in commercial paper is excepted from the competitive bidding requirements of Rule 50 of the Act, under Rule 50 (a) (5).
