**EXCHANGE COMMISSION** 

DELEGATION OF AUTHORITY TO GRANT WAIVERS OF IMPUTED DISQUALIFICATION

> Rule 8(d) of the Commission's Conduct Regulation, 17 CFR 200.735-8(d) currently provides a procedure by which law firms with which former Commission employees become associated, can obtain waivers of imputed disqualification. The Commission approved an amendment to its regulation delegating to the General Counsel the authority to grant such waivers. (Rel. 33-6382)

## **ADMINISTRATIVE PROCEEDINGS**

THOMAS J. FURNARI, HILLEL MAEIR CITED

The Commission announced that it has instituted public administrative proceedings under the Securities Exchange Act of 1934 against Thomas J. Furnari and Hillel Maeir, registered representatives with national broker-dealers.

The Order for Proceedings alleges that while Furnari and Maeir were employed at the same broker-dealer, they wilfully violated the antifraud provisions of the securities laws in connection with the offer, purchase and sale for their customers of various publicly traded option contracts. As a result of Furnari's and Maeir's conduct, during an eight month period, four customers lost over a quarter of a million dollars and Furnari and Maeir generated over \$91,000 in commissions.

A hearing will be scheduled to take evidence on the allegations against Furnari and Maeir and to afford them an opportunity to present any defenses they may have. purpose of the hearing is to determine whether or not the allegations against them are true, and if so, to decide what, if any, remedial action is necessary in the public interest. ## CIVIL PROCEEDINGS

#### T. E. SLANKER ENJOINED AND SIPC RECEIVER APPOINTED

The Seattle Regional Office announced that on January 29 the U.S. District Court for the District of Oregon granted the Commission's summary judgment motion and entered an order of permanent injunction against T. E. Slanker Co., T. E. Slanker Co., Inc., and Ted E. Slanker, Jr., all of Portland, Oregon, enjoining said defendants from further violations of the net capital rule and the customer protection rule of the Securities Exchange Act of 1934. Further, on February 4, said court also granted the application of SIPC to appear in the case and appointed a temporary receiver until such time as the hearing could be held as to the appointment of a trustee.
