PROPOSAL TO AMEND RULE 6a-2 AND FORMS 1 AND 1-A

If adopted the amendments would delete certain duplicative and obsolete items from the Forms, as well as modifying other items to reflect recent changes in the Act and the structure and operation of the exchanges. # HOLDING COMPANY ACT RELEASES

LOUISIANA POWER & LIGHT COMPANY
