INVESTMENT COMPANY ACT RELEASES

THE FLEX-PARTNERS AND MUTUAL FUND PORTFOLIO

A notice has been issued giving interested persons until April 1 to request a hearing on an application filed by The Flex-Partners and Mutual Fund Portfolio for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Section 12(d)(1)(F)(ii) of the Act. The order would permit a class of shares of the TAA Fund, a series of The Flex-Partners, to be offered to the public with a sales load that exceeds the sales load limitation of that section. (Rel. HOLDING COMPANY ACT RELEASES

CINERGY CORPORATION, ET AL.

A supplemental order has been issued authorizing Cinergy Corporation (Cinergy), a registered holding company, Cinergy Services, Inc., a subsidiary service company, and Cinergy Investments Inc., a nonutility subsidiary company to engage in financing. Specifically, the applicants propose to make direct or indirect investments in special purpose subsidiaries, through December 31, 1999, in an aggregate amount which, when added to Cinergy's aggregate investment in all exempt wholesale generators, foreign utility companies, and special purpose subsidiaries, does not, at any point in time, exceed 50% of Cinergy's consolidated retained earnings. UNITIL CORPORATION, ET AL.

A notice has been issued giving interested persons until April 1 to request a hearing on a proposal by Unitil Corporation (Unitil), a registered holding company, its wholly-owned non-utility subsidiary, Unitil Resources, Inc. (URI), and its wholly-owned service company subsidiary, Unitil Service Corp. (Unitil Service) (collectively, Applicants). Applicants seek authorization for URI to expand its energy related management and consulting services business to engage in transactions as a retail and wholesale marketer of electricity, gas and other energy commodities and to provide certain energy management services to customers, including demand side management and energy usage consulting services. Applicants also request authorization for Unitil to provide URI with certain indemnifications and guarantees, and for Unitil Service to provide URI with facilities, personnel and services necessary for its energy marketing and energy management services activities. NEW ENGLAND ELECTRIC SYSTEM

A notice has been issued giving interested persons until April 1 to request a hearing on a proposal by New England Electric System (NEES), a registered holding company, to form one or more subsidiary companies (Marketing Companies) in Massachusetts, Rhode Island, New Hampshire, New York, New Jersey, Pennsylvania, Maryland and Delaware to engage in the wholesale and retail marketing of electricity.

NEES proposes to finance the Marketing Companies by purchasing 1,000 shares of their capital stock, for a total purchase price of \$1,000, and making capital contributions and/or loans through December 31, 1999, in an amount not to exceed \$15 million. The Marketing Companies propose to enter service agreements with NEES' retail operating companies, its service company, New England Power Service Company, and New England Power Company, under which their personnel and other resources may be used to support the Marketing Companies in connection with their authorized activities. APPROVAL OF AMENDMENT TO JOINT INDUSTRY PLAN

The Commission approved Amendment No. 8 to a Joint Industry Reporting Plan for Nasdaq/National Market securities traded on an exchange on an unlisted or listed basis, submitted by the National Association of Securities Dealers, Inc., and the Boston, Chicago and Philadelphia Stock Exchanges (File No. S7-24-89). The Commission's approval order extends the effectiveness of the Plan and extends certain exemptive relief granted by the Commission in conjunction with the Plan through March 15, 1996. APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filing (SR-Phlx-95-92) by the Philadelphia Stock Exchange that would list and trade options on the Phlx OTC Industrial Average Index, a price weighted index developed by the Phlx composed of some of the largest stocks, by capitalization, traded through NASDAQ/NMS. Publication of the notice is expected in the Federal Register during the week of March 11. (Rel. 34-36935)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-96-7) that reclassifies Nasdaq National Market securities into appropriate tier sizes for purposes of determining the maximum size order for a particular security eligible for execution through Nasdaq's Small Order Execution System (SOES) and

the minimum quotation size requirements for Nasdaq market makers in these securities. Because this proposed rule change was done pursuant to an NASD stated policy and practice, it became effective immediately pursuant to Section 19(b)(3)(A)(i) of the Act and subparagraph (e) of Securities Exchange Act Rule 19b-4. The rule change provided for the reclassification to be effective beginning April 1, 1996. Publication of the proposal is expected in the Federal Register during the week of March 11. (Rel. 34-36932)

The Philadelphia Depository Trust Company filed a proposed rule change (SR-Philadep-95-13). The rule change provides Philadep participants with access to several additional Institutional Delivery system features through their Philanet terminals. The rule change became effective upon filing. Publication of the proposal is expected in the Federal Register during the week of March 11. (Rel. 34-36939)

PROPOSED RULE CHANGE

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-96-02) to modify the minimum financial requirement for category one interdealer broker membership in the netting system. (Rel. 34-36945)
