ENFORCEMENT PROCEEDINGS

CLAUDE COSSU PERMANENTLY ENJOINED

The Commission announced that on November 29, 2000, the Hon William B Shubb, United States District Court Judge, entered a final judgment of permanent injunction against defendant Claude Cossu (Cossu) of Fairfield, California, by his consent, in which he neither admitted nor denied the allegations in the SEC's amended complaint The final judgment permanently restrained and enjoined Cossu from violating the securities transaction registration, antifraud, and broker dealer registration requirements of the federal securities laws Cossu also was ordered to disgorge \$394,065 in ill-gotten gains, but, based on evidence that Cossu lacked the financial ability to pay any amount, the Court waived payment of disgorgement and declined to impose a civil money penalty.

The permanent injunction followed a complaint filed by the SEC on May 31, 2000, and amended on November 28, 2000, alleging that between May 1998 and August 1999, Cossu made material misrepresentations and omissions in connection with the offer and sale of securities in unregistered non-exempt transactions, in the form of purportedly high interest promissory notes, in Sebastian International Enterprises, Inc (SIE) The amended complaint alleged that Cossu's misrepresentations concerned the risk and safety of SIE's securities, the ability of SIE to pay interest and principal on the notes, and the alleged existence of a surety bond guaranteeing the notes The SEC's amended complaint also alleged that Cossu acted without the specific approval of a registered broker-dealer in the sale of the SIE notes Finally, the SEC's amended complaint alleged that Cossu received ill-gotten gains in the form of commission payments from his sale of Specifically, the amended complaint alleged that Cossu violated SIE's securities. Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a)(1) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder [SEC v Claude Cossu, Case No CIV-S-00-1198 WBS GGH, E D Cal] (LR-16860)

INVESTMENT COMPANY ACT RELEASES

CITYFED FINANCIAL CORP.
