INVESTMENT COMPANY ACT RELEASE

NICHOLAS-APPLEGATE FUND, INC., ET AL.

An order has been issued on an application filed by Nicholas-Applegate Fund, Inc , et al , exempting applicants from section 15(f)(1)(A) of the Investment Company Act in connection with the proposed change in control of Nicholas-Applegate Capital Management The order permits the company, which is subadvised by NACM, not to reconstitute its board of directors to meet the 75 percent non-interested director requirement of Section 15(f)(1)(A) of the Act in order for NACM to rely upon the safe harbor provisions of Section 15(f) (Rel IC-24848 - February 1)
