HOLDING COMPANY ACT RELEASES

ENTERGY LOUISIANA, INC.

A supplemental order has been issued authorizing Entergy Louisiana, Inc (Entergy Louisiana), a public utility subsidiary of Entergy Corporation, a registered holding company, to consent to the execution by River Fuel Company # 2, Inc., a non-associate company, of a new credit agreement to be used to finance the acquisition of nuclear fuel for Entergy Louisiana's Waterford 3 nuclear generating unit. (Rel. 35-27360)

NISOURCE INC., ET AL.

A supplemental order has been issued authorizing NiSource Inc., (NiSource), a registered holding company, its intermediate holding companies, its public utility subsidiary companies, and its nonutility subsidiary companies, collectively (Applicants), through December 31, 2003 (Authorization Period) to increase from \$2 billion to \$3.4 billion the maximum principal amount of short-term debt that NiSource (or any financing subsidiary of NiSource) may have outstanding at any one time. CMS ENERGY CORPORATION

An order has been issued authorizing CMS Energy Corporation (CMS Energy), a public-utility holding company claiming an exemption under Section 3(a)(1) of the Act by Rule 2 under the Act, to acquire indirectly through Consumers Energy Company (Consumers Energy), its wholly owned public utility subsidiary, all of the issued and outstanding voting securities of Michigan Electric Transmission Company, a corporation that will become a public utility subsidiary after it acquires certain transmission assets currently owned by Consumers Energy. PROPOSED RULE CHANGES

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-01-21) relating to primary trading session hours for equities whose primary market is not the Exchange. (Rel. 34-44088)

The Chicago Stock Exchange filed a proposed rule change (SR-CHX-01-06) to amend its SuperMAX 2000 price improvement algorithm to permit application of the algorithm to odd lot orders. Publication of the notice in the Federal Register is expected during the week of March 26. (Rel. 34-44090)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-00-69) to establish a new registration category: Limited Representative – Private Securities Offerings. Publication of the notice in the Federal Register is expected during the week of March 26. (Rel. 34-44091)

APPROVAL OF EXTENSION OF TEMPORARY REGISTRATION AS A CLEARING AGENCY

The MBS Clearing Corporation (MBSCC) filed a request for extension of its registration as a clearing agency under Section 17A of the Securities Exchange Act of 1934. The Commission has extended MBSCC's temporary registration as a clearing agency through September 30, 2001 (File No. 600-22). Publication of the notice and order is expected in the Federal Register during the week of March 26. (Rel. 34-44089)
