ENFORCEMENT PROCEEDINGS

SEC SETTLES CIVIL ACTION AGAINST TWO TENNESSEE BROKERS IN MID OCEAN LTD. INSIDER TRADING CASE

The Commission announced today that the United States District Court for the Middle District of Tennessee ordered two stockbrokers, Cristian K Blackman and Charles R. Roberts, to pay disgorgement and civil money penalties totaling almost \$450,000 based on allegations that they engaged in insider trading in stock or options of Mid Ocean Ltd. (Mid Ocean).

In November 1999, the SEC filed a complaint against Blackman and Roberts, both of whom formerly worked at the Nashville office of Morgan Keegan & Co. (Morgan Keegan), a brokerage firm, alleging that Blackman learned that Mid Ocean would be taken over shortly before a March 16, 1998 announcement that Exel Ltd., a Bermuda reinsurance company, would acquire Mid Ocean. The SEC alleged that Blackman tipped Roberts about Mid Ocean. The SEC's complaint further alleged that on March 13, 1998, Blackman purchased Mid Ocean call options and 3,000 shares of Mid Ocean stock, and Roberts purchased 1,000 shares of Mid Ocean stock. In addition, the complaint alleged that Blackman tipped his brother and three of his clients, and Roberts tipped twelve of his clients, about Mid Ocean.

The injunction against Blackman, which was entered March 16, 2001, and the injunction against Roberts, which was entered on March 26, 2001, prohibit them from violating Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The court also ordered Blackman to disgorge \$141,558.50, representing the profits earned by Blackman, his brother and his three clients, plus pre-judgment interest. The court ordered Roberts, jointly and severally with Blackman, to disgorge \$175,850, representing the profits earned by Roberts and his twelve clients, plus pre-judgment interest. Finally, the court ordered Blackman and Roberts to pay civil penalties of \$78,125 and \$12,250, respectively, representing their own profits from trading in Mid Ocean stock or options.

Blackman and Roberts were the last remaining defendants in the SEC's action alleging insider trading in connection with Exel's takeover of Mid Ocean. Previously, the SEC settled its cases against Blackman's alleged tipper, and several others who allegedly traded or tipped others about the Mid Ocean takeover (see Litigation Release No. 16357,

November 17, 1999). The SEC acknowledges the assistance of the American Stock Exchange in investigating this matter. [SEC v. Cristan K. Blackman, et al., Case No. 3:99-1072, Haynes, J., MD Tenn.] (LR-16953)

INVESTMENT COMPANY ACT RELEASES

NEW ENGLAND LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until April 26 to request a hearing on an application filed by New England Life Insurance Company, New England Variable Life Separate Account (New England Separate Account 1), Metropolitan Life Insurance Company, The New England Variable Account (New England Separate Account 2), the Metropolitan Series Fund, Inc. (Metropolitan Fund), and the New England Zenith Fund (Zenith Fund) (collectively, Applicants). Applicants request an order under Section 26(b) of the Investment Company Act to permit New England Separate Account 1 and New England Separate Account 2 to substitute Class A shares of the MetLife Stock Index Portfolio of the Metropolitan Series for shares of the Westpeak Stock Index Series of the Zenith Fund. Applicants also request an order under Section 17(b) of the Act for an exemption from Section 17(a) of the Act to permit certain in-kind transactions in connection with the substitution. (Rel. STATE FARM LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until April 27 to request a hearing on an application filed by State Farm Life Insurance Company (Life Company), State Farm Life and Accident Assurance Company (Accident Company), State Farm Life Insurance Company Variable Annuity Separate Account (Life Company VA Separate Account), State Farm Life and Accident Assurance Company Variable Annuity Separate Account (Accident Company VA Separate Account, and together with the Life Company VA Separate Account, the Separate Accounts), State Farm Mutual Fund Trust (Retail Fund) and State Farm VP Management Corp. (VP Management Corp.) (collectively, Applicants). Applicants request an order under Section 11 of the Investment Company Act permitting exchanges between individual deferred variable annuity contracts (Contracts) of the Separate Accounts or any future Contracts offered by Life Company, Accident Company or any current and future affiliated insurance company and Retail Fund or any other registered, open-end management investment companies sponsored, organized and advised by a subsidiary of State Farm Mutual Automobile Insurance Company, the parent of Life Company, Accident Company and VP Management Corp. (Rel. IC-24927 – April 5)

THE TRAVELERS TIMED BOND ACCOUNT FOR VARIABLE ANNUITIES

An order has been issued under Section 8(f) of the Investment Company Act declaring that Travelers Timed Bond Account for Variable Annuities has ceased to be an investment company. (Rel. IC-24928 – April 5)

JACKSON NATIONAL LIFE INSURANCE COMPANY OF NEW YORK, ET AL.

A notice has been issued giving interested persons until April 27 to request a hearing on an application filed by Jackson National Life Insurance Company of New York (Jackson National NY), JNLNY Separate Account I (Separate Account I-NY), Jackson National Life Distributors, Inc. (JNLD) (collectively, Applicants). Applicants seek an order under Section 6(c) of the Act to the extent necessary to permit, under specified circumstances, the recapture of credits applied to premiums made under deferred variable annuity contracts that Jackson National NY will issue through Separate Account I-NY (the Contracts), as well as other contracts that Jackson National NY may issue in the future through any other separate account established by Jackson National NY in the future to support certain deferred variable annuity contracts issued by Jackson National NY (Future Accounts) that are substantially similar in all material respects to the Contracts (the Future Contracts). Applicants also request that the order being sought extend to any other National Association of Securities Dealers, Inc. (NASD) member broker-dealer controlling or controlled by, or under common control with, Jackson National NY, whether existing or created in the future, that serves as a distributor or principal underwriter for the Contracts or Future Contracts offered through Separate Account I-NY or any Future Account. THE SOUTHERN COMPANY

A notice has been issued giving interested persons until April 30 to request a hearing on a proposal by The Southern Company (Southern), a registered public utility holding company, to grant, from time to time through May 22, 2011, Incentive Stock Options, Nonqualified Stock Options, Stock Appreciation Rights, Restricted Stock, Restricted Stock Units, Performance Shares, Performance Units and Cash Based Awards and to issue 30 million shares of its common stock, under the Southern Company Omnibus Incentive Compensation Plan (Plan). An order has been issued authorizing Southern to solicit proxies from its stockholders in connection with the submission of the Plan for consideration and action at the annual meeting of stockholders to be held on May 23, 2001.
