## RULES AND RELATED MATTERS

---

### EXEMPTIONS FROM RULES 10b-6, 10b-7, AND 10b-8 DURING DISTRIBUTIONS OF CERTAIN UNITED KINGDOM SECURITIES AND CERTAIN SECURITIES TRADED ON SEAQ INTERNATIONAL

Pursuant to delegated authority, on January 10 the Division of Market Regulation issued a letter granting class exemptions from Rules 10b-6, 10b-7, and 10b-8 (Trading Practice Rules) under the Securities Exchange Act of 1934 (17 CFR 240.10b-6, 10b-7, and 10b-8) to facilitate distributions in the United States of securities of certain highly capitalized United Kingdom issuers and issuers whose securities are traded on SEAQ International. The exemptions permit transactions that otherwise would be prohibited by the Trading Practice Rules, subject to certain disclosure, recordkeeping, record production, and notice requirements. ## ENFORCEMENT PROCEEDINGS

---

### PRELIMINARY INJUNCTION ENTERED IN WIRELESS CABLE CASE

The Commission announced that on January 12 the Honorable Nicholas H. Politan of the United States District Court for the District of New Jersey entered a preliminary injunction order against Future Vision Direct Marketing, Inc., Global Wireless, L.L.C., Worldwide Wireless, L.L.C., Caracas Wireless Communication, L.P., Global Communications Holding Corp., S & G Management, Inc., Philip Forma, Sr., James Barschow, Bruce Schroeder and Joseph Glenski. The preliminary injunction enjoins the defendants from future violations of the registration, antifraud and broker-dealer registration provisions of the

securities laws and keeps in place an earlier freeze of assets. The Commission alleges that the defendants raised approximately \$3.5 million through the sale of membership interests in so-called limited liability companies and limited and general partnership interests. The Commission further alleges that the offering materials failed to disclose material information, such as the individual defendants significant financial interests in the offering, and the misappropriation of investor funds.

On October 3, 1994, Judge Politan had entered an Order temporarily restraining the defendants from future violations of the charged provisions, and freezing their assets. [SEC v. Future Vision Direct Marketing, Inc., et al., D.N.J., Civil Action No. 94-4806] (LR-14384)

**COMPLAINT FILED AND TEMPORARY RESTRAINING ORDER ISSUED AGAINST GEMCO OIL DEVELOPMENT, INC. GENERAL MINERALS CORPORATION, CARL ROYSE AND JEANNETTE GRAHAM**

The Commission announced that on December 29, 1994 the Honorable Wilkie D. Ferguson, Jr., U.S. District Judge for the Southern District of Florida, issued an order which, among other things, temporarily restrains the defendants Gemco Oil Development, Inc. (Gemco), General Minerals Corporation (General Minerals), Carl E. Royse (Royse), and Jeannette Graham (Graham) from further violations of the registration, antifraud and broker-dealer registration provisions of the federal securities laws, freezes the assets of defendants Royse and Graham, and appoints a receiver for defendants Gemco and General Minerals. The Commission's complaint, filed on December 27, 1994, seeks preliminary and permanent injunctions and ancillary relief against the defendants.

The complaint alleges that since at least April 1991 Graham and Royse knowingly, willfully and/or recklessly caused Gemco and General Minerals to utilize boiler room operations to fraudulently offer and sell oil and gas investments to the general public in an unregistered, nonexempt public distribution. The Complaint further alleges that Gemco and General Minerals are nothing more than Ponzi schemes.

The complaint also alleges that Royse and Graham participated in the sale of Gemco and General Minerals securities to the public, without registering as broker-dealers. [SEC v. **INVESTMENT COMPANY ACT RELEASES**

---

**CORPORATE NETWORK MUTUAL FUND**

An order has been issued under Section 8(f) of the Investment Company Act declaring that Corporate Network Mutual Fund has ceased to be an investment company. (Rel. IC-20841 - January 18)

## CREDITANSTALT-BANKVEREIN

An order has been issued on an application filed by Creditanstalt-Bankverein under Section 6(c) of the Investment Company Act for an exemption from Section 17(f) of the Act. The order permits applicant's subsidiary in Hungary to act as custodian for investment company assets. (Rel. IC-20842; International Series Rel. 771 - January 18)

## MID CAP SPDR TRUST, SERIES 1 AND PDR SERVICES CORPORATION

An order has been issued under Section 6(c) of the Investment Company Act exempting Mid Cap Spdr Trust, Series 1 (Trust) and PDR Services Corporation from Sections 4(2), 14(a), 17(a), 22(d), 22(e), 24(d), 26(a)(2)(C), and Rule 22c-1; under 17(b) granting an exemption from Sections 17(a)(1) and 17(a)(2); and under Rule 17d-1 to permit certain joint transactions with affiliates. The order permits, among other things: the Trust, a unit investment trust, to issue non-redeemable securities (Mid Cap Spdrs); secondary market transactions in Mid Cap Spdrs at negotiated prices, rather than at a current public offering price described in the prospectus; and dealers to sell Mid Cap Spdrs to purchasers in the secondary market unaccompanied by a prospectus, when prospectus delivery is not required by the Securities Act of 1933. ## JOHN HANCOCK SOVEREIGN BOND FUND, ET AL.

An order has been issued on an application filed by John Hancock Sovereign Bond Fund, et al. under Section 6(c) of the Investment Company Act granting an exemption from Sections 13(a)(2), 13(a)(3), 18(a), 18(c), 18(f)(1), 22(f), 22(g) and 23(a) of the Act, and Rule 2a-7 thereunder, under Sections 6(c) and 17(b) of the Act granting an exemption from Section 17(a)(1), and under Section 17(d) of the Act and Rule 17d-1 thereunder. The order permits certain investment companies to enter into deferred compensation arrangements with their independent trustees. (Rel. IC-20843 - January 18)
