## ENFORCEMENT PROCEEDINGS

---

### CEASE-AND-DESIST PROCEEDINGS AND ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST DAVID LEE ULLOM

The Commission instituted cease-and-desist proceedings and administrative proceedings against David Lee Ullom (Ullom), president of a former registered investment adviser, Oxxford Asset Management, Inc. (Oxxford). The Order Instituting Proceedings alleges that Ullom caused Oxxford's records to be falsified to mislead a state examiner into believing that Oxxford was inactive, and then submitted an amended Form ADV to the Commission falsely stating that Oxxford had no clients and no funds under management. The Order alleges that Oxxford in fact had four clients with \$278,000 under management. The Order also alleges that Ullom distributed a brochure containing misleading performance figures, and caused Oxxford not to timely file its annual Form ADV-S, all in violation of various provisions of the Investment Advisers Act of 1940.

A hearing will be scheduled to take evidence on the staff's allegations and to afford the respondent an opportunity to present any defenses thereto. (Rels. 34-35226; IA-1461)

## INVESTMENT COMPANY ACT RELEASES

---

### ANCHOR NATIONAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until February 13 to request a hearing on an application by Anchor National Life Insurance Company (Anchor National), Variable Annuity Account Two (Separate Account), and Vista Broker-Dealer Services, Inc. for an order under Section 6(c) under the Investment Company Act. The order would grant exemptions from Sections 26(a)(2) and 27(c)(2) of the Act to the extent

necessary to permit the deduction of mortality, expense risk, and distribution expense risk charges from the assets of the Separate Account under certain individual and group variable annuity contracts (Contracts) funded through the Separate Account, and under materially similar contracts which may be funded in the future through the Separate Account; and from the assets of any other separate account established in the future by Anchor National in connection with the issuance of contracts which are materially similar to the Contracts. SUNAMERICA INC., ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting SunAmerica Inc., Anchor National Life Insurance Company (Anchor National), Variable Separate Account (Separate Account) and SunAmerica Capital Services, Inc. from Section 22(d) of the Act. The order provides exemptions to the extent necessary to permit Anchor National or any other insurance company controlling, controlled by, or under common control with, Anchor National (collectively, Affiliated Insurers) to waive, in certain circumstances, the contingent deferred sales charge that otherwise would be imposed on certain individual and group flexible payment deferred variable annuity contracts issued and to be issued by Anchor National and the Affiliated Insurers. THE TRAVELERS INSURANCE COMPANY, ET AL.

The Commission issued an order under Section 6(c) of the Investment Company Act amending certain existing orders granting exemptions to The Travelers Insurance Company (Travelers), The Travelers Growth and Income Stock Account for Variable Annuities, The Travelers Quality Bond Account for Variable Annuities, The Travelers Money Market Account for Variable Annuities, The Travelers Timed Growth and Income Stock Account for Variable Annuities, The Travelers Timed Short-Term Bond Account for Variable Annuities, The Travelers Timed Aggressive Stock Account for Variable Annuities, The Travelers Timed Bond Account for Variable Annuities, The Travelers Fund U for Variable Annuities, The Travelers Fund BD for Variable Annuities, The Travelers Fund UL for Variable Life Insurance, Copeland Financial Services, Inc, and Travelers Equities Sales, Inc. (TESI). The order amends certain existing orders granting exemptions from Sections 2(a)(32), 11, 12(b), 14(a), 15(a), 16(a), 17(d), 17(f), 22(c), 22(d), 22(e), 26(a)(2), 27(a)(2), 27(a)(4), 27(c)(1), 27(c)(2), 27(d), and 32(a)(2) of the 1940 Act, and Rules 17d-1, 17f-2, 22c-1, 12b-1, 6e-3(T)(b)(12), 6e-3(T)(b)(13) and 6e-3(T)(c)(2) thereunder, to specify that TESI acts as principal underwriter with respect to certain variable annuity and variable life insurance contracts issued by Travelers and to grant TESI exemptive relief in accordance with the relief previously granted to Travelers in its capacity as principal underwriter of the Contracts.
