ENFORCEMENT PROCEEDINGS

INITIAL DECISION IN THE MATTER OF MEYER BLINDER

Judge Brenda P. Murray barred Meyer Blinder from association with any broker or dealer and from association with any member of a national securities exchange or registered securities association based on Mr. Blinder's criminal conviction, a civil injunction, and public interest considerations. Mr. Blinder is serving three concurrent 46-month terms at the Federal Correctional Facility in Tallahassee, Florida, as a result of his criminal conviction for violating the Securities Act of 1933 and certain provisions of the anti-racketeering laws. In the civil action, Mr. Blinder and a corporation he controlled were ordered to disgorge \$24 million. Mr. Blinder maintains that he was doing nothing but good and helping people. (Initial Decision No. 60)

CIVIL ACTION AGAINST ANGELO CORONATO, LAURENCE CORONATO, ROBERT ROGOFF AND JOSEPH CUSENZA

The Commission announced the filing of a complaint in the United States District Court for the District of New Jersey on January 24 against Angelo A. Coronato (Coronato), the former chief executive officer and chairman of the board of directors of RCM Technologies, Inc., (RCM), a Nevada corporation; Laurence W. Coronato (LW Coronato), Coronato's son; Robert Rogoff (Rogoff), LW Coronato's boss; and Joseph V. Cusenza (Cusenza), a former director of RCM. The complaint alleges that during June 1992, Coronato, LW Coronato, Rogoff, and Cusenza, each sold RCM common stock while in possession of material nonpublic information that the only product of an RCM subsidiary, a developmental stage pollution control process known as System 99, was neither technically feasible nor commercially viable.

The complaint alleges that, as a result of the foregoing conduct, each of the defendants violated Section 10(b) of the Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. The complaint seeks permanent injunctions against each of the defendants, disgorgement of losses avoided plus prejudgment interest on the amounts to be disgorged, and civil penalties pursuant to Section 21A of the Exchange Act. CIVIL ACTION AGAINST BROADCAST ASSOCIATES-I, ET AL.

The Commission filed an injunctive action against Broadcast Associates - I, Broadcast Acquisitions, Inc., Broadcast Holdings, Inc., Arthur A. Graves, III, and Gregory P. Moeller alleging violations of Sections 5 and 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, in connection with the offering of investment contracts in wireless cable television ventures. The Commission seeks permanent injunctions, disgorgement, civil penalties, and interim relief as to certain of the defendants. Simultaneously with the filing of the Complaint, defendants Broadcast Associates - I, Broadcast Acquisitions, and Graves consented to the entry of a preliminary injunction and an order freezing certain assets and requiring them to provide an accounting.

The Commission alleges that, from in or about November 1992 until the present, the defendants made material misrepresentations in the offering of interests in Broadcast Associates - I, including misrepresentations as to forfeiture of investor funds in the event of the failure to consummate the acquisition of one system; projected return on investment; use of proceeds, particularly as to commissions to be paid; existence of the rights to acquire the systems; operating history of one of the systems; ownership of some of the systems; and dissipation of funds previously paid by investors. In addition, the Commission alleges that the defendants failed to register the interests with the Commission. The defendants raised approximately \$4.5 million from approximately 300 investors. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The Midwest Clearing Corporation and Midwest Securities Trust Company filed proposed rule changes (SR-MCC-94-15 and SR-MSTC-94-18) which became effective upon filing with the Commission. The rule changes eliminate the right of MBS Clearing Corporation (MBS) to collect monies from the MCC Participants Fund or from the MSTC Participants Fund when an MCC or an MSTC participant, respectively, fails to discharge a liability to MBS.
