COMMISSION ANNOUNCEMENTS

FERNANDO ALEGRIA, JR. TO TESTIFY

Fernando Alegria, Jr., Associate Executive Director of the Office of Administrative and Personnel Management of the SEC will testify before the House Subcommittee on Civil Service on Tuesday, February 7, 1995, at 9:30 a.m. The hearing will be held in Room 2203 of the Rayburn House Office Building. The subject matter will be proposals to restructure and downsize the United States Office of Personnel Management.

ENFORCEMENT PROCEEDINGS

DAVID DENNIS VAN PELT INDICTED IN SECURITIES FRAUD SCHEME

On January 27, the Grand Jury for the Eastern District of California indicted David Dennis Van Pelt on fifteen counts of Securities Fraud (15 U.S.C. §§ 78j(b) and 78 ff and 17 C.F.R. § 240.10b-5); thirty eight counts of Mail Fraud (18 U.S.C. § 1341); and twenty three counts of Money Laundering (18 U.S.C. § 1956(a)(1)(A)(i).

The Indictment alleges that from November, 1990 through June, 1992, David Dennis Van Pelt, in connection with the purchase or sale of stock in DBS Network, Inc., a company purported to be a viable, commercial developer of direct broadcast satellite technology in the United States, made false representations to investors. The scheme consisted of making false representations concerning the status of FCC licenses; contracts and negotiations between DBS Network, Inc. and builders and launchers of commercial satellites; financing commitments that DBS Network, Inc. had purportedly obtained; and the value of the stock in DBS Network, Inc. [U.S. v. David Dennis Van Pelt, Criminal Action No. CR-S-95-47, ELG, ED Cal.] (LR-14397)

HOLDING COMPANY ACT RELEASES

ALLEGHENY POWER SYSTEM, INC., ET AL.

An order has been issued authorizing Allegheny Power System, Inc., a registered holding company, and AYP Capital, Inc., its wholly owned nonutility subsidiary, to invest from time to time through December 31, 2002, up to \$5 million as a limited partner in the EnviroTech Investment Fund I Limited Partnership, a fund which invests in companies commercializing electrotechnologies and renewable energy technologies. (Rel. 35-26225)

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A supplemental order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, and its subsidiary companies, Central and South West Services, Inc. (CSWS), Central Power and Light Company, Public Service Company of Oklahoma, Southwestern Electric Power Company, West Texas Utilities Company and Transok, Inc., to increase CSW's overall borrowing authority from \$930 million to \$950 million, to issue, sell and acquire short-term notes under short-term borrowing programs and the CSW System Money Pool through March 31, 1995. The Commission continues to reserve jurisdiction over \$40 million of CSWS' proposed borrowing authority. (Rel. 35-26226)

WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until February 23 to comment on the application of Three-Five Systems, Inc. to withdraw its Common Stock, \$0.01 Par Value, from listing and registration on the American Stock Exchange. (Rel. 34-35317)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>Chicago Board Options Exchange</u> (SR-CBOE-94-19), and has granted accelerated approval of Amendment No. 2 to the proposed rule change, relating to the listing and trading of options and long-term options on the CBOE Emerging Markets Index and long-term options on a reduced-value CBOE Emerging Markets Index. Publication of the notice and approval order is expected in the <u>Federal Register</u> during the week of February 6. (Rel. 34-35303)

The Commission approved a proposed rule change filed by the <u>Chicago Board Options Exchange</u> (SR-CBOE-94-20), and has granted accelerated approval of Amendment No. 2 to the proposed rule change, relating to the listing and trading of options and long-term options on the CBOE Emerging Asian Markets Index and long-term options on a reduced-value CBOE Emerging Asian Markets Index. Publication of the notice and approval order is expected in the <u>Federal Register</u> during the week of February 6. (Rel. 34-35304)

PROPOSED RULE CHANGES

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-PHLX-94-61) to amend Floor Procedure Advice F-8, "Failure to Comply with an Exchange Inquiry," to require participants, as well as members, to comply with Exchange requests for information in connection with any regulatory inquiry, investigation, or examination relating to the Exchange's disciplinary jurisdiction or regulatory obligations. In addition, the PHLX proposes to amend Advice F-B to reduce the fine for the first violation of the Advice from \$500 to \$200 and to provide that each additional request for information not furnished within the allotted time period may be considered as a separate occurrence for purposes of the Advice's fine schedule. Publication of the notice is expected in the <u>Federal Register</u> during the week of February 6. (Rel. 34-35305)

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-PHLX-94-69) to amend its rules to establish a one-year pilot program allowing the PHLX to list and trade municipal securities. Publication of the notice is expected in the <u>Federal Register</u> during the week of February 6. (Rel. 34-35308)

The <u>Pacific Clearing Corporation</u> filed a proposed rule change (SR-PCC-94-01) that corrects typographical errors to PCC's rules and makes certain clarifications to PCC's standard participant agreement and clearing fund agreement regarding post capital. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 6. (Rel. 34-35313)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-95-11) relating to listing standards for options on securities issued in certain corporate restructuring transactions.
