### CONSUMER AFFAIRS ADVISORY COMMITTEE MEETING SCHEDULED

## ENFORCEMENT PROCEEDINGS

---

### ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST FORMER VICE PRESIDENT AT PRUDENTIAL SECURITIES

The Commission has instituted public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against Bede F. Howard (Howard), formerly a registered representative and vice president at Prudential Securities Inc.

The Order Instituting Public Proceedings (Order) alleges that on November 19, 1992, Howard was convicted of criminal charges of fraud by deception and sentenced to three years imprisonment in connection with his misappropriation of over \$700,000 from his investor clients' accounts. The Order further alleges that, on July 15, 1994, in connection with this same conduct, Howard was permanently enjoined by default by the United States District Court of New Jersey from violations of Section 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder (SEC v. Bede F. Howard a/k/a Howard F. Bede, 94 Civ. 285, AMW, D.N.J., 1994).

A hearing will be scheduled to determine what remedial sanctions, if any, are appropriate against Howard in light of his conviction and the injunction entered against him. (Rel. 34-35336)

### NORMAN BROOKS PLEADS GUILTY AND HIS SON SENTENCED IN BOILER-ROOM CASE

The Commission and the U.S. Attorney for the District of New Hampshire announced that on February 6 Norman L. Brooks pled guilty to a five count criminal information charging him with conspiracy to commit securities, mail and wire fraud, racketeering, money laundering and tax violations; and James A. Brooks (a.k.a. David Gertzinger), N. Brooks' son, was sentenced to incarceration for ten months for his previous plea of guilty to charges of perjury and conspiracy to commit mail and wire fraud. The criminal charges to which N. Brooks pled guilty were related to securities fraud and other civil charges brought against N. Brooks and J. Brooks in a Complaint filed by the Commission in the U.S. District Court for the District of New Hampshire on April 5, 1994. The perjury count for which J. Brooks was sentenced arose from a false declaration made and filed by J. Brooks in opposition to relief the Commission was seeking against J. Brooks in its civil enforcement action. Final judgments have been entered against both N. Brooks and J. Brooks by default, although the Court has retained jurisdiction over both in the Commission's civil action pending a determination of the appropriate amounts of disgorgement and civil penalties. stock, \$2.50 par value, from 150,000,000 to 350,000,000 and eliminate the rights of its shareholders to purchase additional shares of GPU common stock in certain circumstances. ### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The proposed rule change also amends the Stockholders Agreement to conform to OCC's restated certificate of incorporation providing for public directors. The rule change became effective upon filing. The Commission approved a proposed rule change submitted by the American Stock Exchange (SR-Amex-94-50) to adopt Commentary .02 to Rule 60 whereby the NYSE will not be held liable for damages sustained by an Amex member's or member organization's use of any NYSE system, service, or facility.
