ENFORCEMENT PROCEEDINGS

KENNETH WEINBERG AND KENNETH LAMPASONA BARRED

The Commission today announced the institution and settlement of public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940 against Kenneth L. Weinberg (Weinberg) and Kenneth G. Lampasona (Lampasona).

On November 10, 1994, a permanent injunction was entered by consent in the Southern District of New York against Weinberg, Lampasona, Kenneco Capital Corporation and its sole shareholder, Kenneco Group, Inc. (SEC v. Weinberg, et al., 94 Civ. 7127, LAK, SDNY, November 18, 1994). The complaint in the above action alleged that Weinberg and Lampasona participated in a scheme to defraud the limited partners of Montvine Associates, L.P. through the use of fraudulent offering materials and false monthly account statements. The complaint also alleged that Weinberg and Lampasona acted unlawfully in controlling an unregistered broker-dealer in securities.

Weinberg and Lampasona, without admitting or denying the allegations of the Commission's complaint, consented to the imposition of remedial sanctions, based upon the entry of consent injunctions against them. They have been permanently barred from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. (Rel. 34-35441; IA-1477)

FOURTEEN INDIVIDUALS NAMED IN CIVIL AND ADMINISTRATIVE ACTIONS RELATING TO COLONIAL REALTY COMPANY

The Commission announced the filing of a complaint against Jonathan N. Googel, Benjamin J. Sisti, William P. Candelori, Kevin Sisti, Kenneth A. Zak, Peter J. Curley and Edmund M. Autuori in the U.S. District Court for Connecticut relating to a fraudulent unregistered public offering by Colonial Realty Company (Colonial) of interests in the Colonial Constitution Limited Partnership between September 1, 1989 and September 1990. Simultaneously with the filing of the complaint, Googel, B. Sisti and Curley consented to an entry of an injunction against further violations of the antifraud and registration provisions of the securities laws. Googel and B. Sisti also agreed to be barred from acting as an officer or director of a public company and to disgorge the sums of \$4,260,597 and \$3,853,089, respectively, plus prejudgment interest thereon, provided, however, that payment of such amounts shall be waived based on their demonstrated inability to pay.

The Commission also instituted and settled public administrative proceedings against Diane Brunell Kaechele, Peter T. Frankel, Ronald F. Milardo and John D. O'Brien, former associated persons of Colonial Equities Corp., the broker-dealer affiliate of Colonial. Kaechele was ordered to cease and desist from committing or causing any violation, and any future violation, of Sections 5(a), 5(c) and 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 promulgated thereunder; and Kaechele, Frankel, Milardo and O'Brien were barred from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

In addition, the Commission instituted public administrative proceedings against James P. Cahill, Frank J. Romeo, Jr. and Richard E. Herman, former associated persons of Equities, based on their criminal convictions. Hearings will be scheduled to determine whether the allegations against Cahill, Romeo and Herman are true, and, if so, what, if any, remedial sanctions are appropriate in the public interest. [SEC v. INVESTMENT COMPANY ACT RELEASES

THE FIRST TRUST SPECIAL SITUATIONS TRUST, ET AL.

A notice has been issued giving interested persons until April 3 to request a hearing on an application filed by The First Trust Special Situations Trust, et al. for an order under Sections 6(c) and 17(b) of the Investment Company Act that would grant an exemption from Section 17(a) of the Act. The order would permit a terminating series of a unit investment trust to sell portfolio securities to a new series of the trust. (Rel. IC-20946 - March 8)

PUTNAM TEXAS TAX EXEMPT INCOME FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Putnam Texas Tax Exempt Income Fund has ceased to be an investment company. (Rel. IC-20947 - March 9)

AETNA INSURANCE COMPANY OF AMERICA, ET AL.

A notice has been issued giving interested persons until April 3 to request a hearing on an application filed by Aetna Insurance Company of America (Aetna); Variable Annuity Account I of Aetna, Variable Annuity Account II of Aetna, and any other Separate Accounts established in the future by Aetna (collectively, Separate Accounts) to support certain variable annuity contracts (Contracts) or such other variable annuity contracts that are substantially similar in all material respects to such Contracts (Other Contracts) and that may be issued in the future by Aetna; and Aetna Life Insurance and Annuity Company and certain other principal underwriters of the Contracts (collectively, Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act exempting them from Sections 26(a)(2)(C) and 27(c)(2) of the Act to permit the deduction of a mortality and expense risk charge from the assets of the Separate Accounts in connection with the offer and sale of the Contracts and the Other Contracts. ML VENTURE PARTNERS II, L.P., ET AL.
