COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT TO TESTIFY

Chairman Levitt will testify before the House Subcommittee on Capital Markets, Securities and Government Sponsored Enterprises of the Committee on Banking and Financial Services on Thursday, March 30, 1995, at 10:00 a.m. The hearing will be held in Room 2128 of the Rayburn House Office Building. Chairman Levitt's testimony concerns H.R. 718, the "Markets and Trading Reorganization and Reform Act."

ENFORCEMENT PROCEEDINGS

INSIDER TRADING COMPLAINT FILED AGAINST JACK SEIBALD, BERNHARD SEIBALD, STEWART SPECTOR, ERIC FESSLER, FRON CAPITAL CORPORATION, AND DEKALB HOLDINGS, INC.

On March 28, the Commission filed an insider trading complaint in the United States District Court for the Southern District of New York against Jack D. Seibald (Seibald), Bernhard Seibald (Bernhard), Stewart R. Spector (Spector), and Eric S. Fessler (Fessler) as defendants, and against Fron Capital Corporation (Fron) and DeKalb Holdings, Inc. (DeKalb) as relief defendants. The complaint seeks permanent injunctive relief, disgorgement of more than \$300,000 in illicit profits (plus interest), and appropriate monetary penalties.

According to the complaint, Seibald, while employed as an equity research analyst at Salomon Brothers Inc., obtained material, nonpublic information relating to public companies he followed and unlawfully conveyed such information to Bernard (his brother and a former stockbroker at Prudential Bache Securities), Spector (his father-in-law and a former managing director of Furman, Selz Inc.), Fessler (his friend), and other persons. The complaint alleges that after receiving such information, Bernhard, Spector, and Fessler unlawfully traded in the securities of the subject companies, which were The Office Club, Inc., Gottschalks, Inc., and Lowe's Companies, Inc., and that Bernhard and Spector also unlawfully traded these securities for the accounts of the relief defendants.

Simultaneously with the filing of the complaint, and without admitting or denying the allegations contained therein, defendant Fessler consented to the entry of a Final Judgment that permanently enjoins him from violating the antifraud provisions of the federal securities laws and orders him to disgorge \$53,000 in illicit profits plus \$21,594 in prejudgment interest. Penalties were not imposed against Fessler due to his demonstrated inability to pay. [SEC v. Jack D. Seibald, et al., USDC/SDNY, Civil Action No. 95-2081] (LR-14449)

HOLDING COMPANY ACT RELEASES

NORTHEAST UTILITIES

A notice has been issued giving interested persons until April 17 to request a hearing on a proposal by Northeast Utilities, a registered holding company, to issue and/or purchase on the open market and sell up to 30 million shares of its common stock under its Dividend Reinvestment Plan, through December 31, 2005. NEW ENGLAND ELECTRIC SYSTEM, ET AL.

A supplemental notice has been issued giving interested persons until April 17 to request a hearing on a proposal by New England Electric Resources, Inc. (NEERI), a wholly owned, nonutility subsidiary of New England Electric System (NEES). NEERI proposes to invest up to \$12.7 million in technology and projects related to coal ash processing and recycling and to acquire certain securities of Separation Technologies, Inc., a nonaffiliate company engaged in such business. NEES proposes to provide financing to NEERI in such amount by capital contributions and/or loans. (Rel. 35-26258)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-95-06) to amend its Interpretation of the Board of Governors - Forwarding of Proxy and Other Material Under Article III, Section 1 of the NASD Rules of Fair Practice. The amendment would allow a beneficial owner of stock to designate a registered investment adviser to vote proxies and receive proxy and related issuer material in lieu of the beneficial owner and would allow certain investment managers of ERISA Plans to vote proxies. Publication of the proposal is expected in the Federal Register during the week of March 27. (Rel. 34-35533)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>American Stock Exchange</u> (SR-Amex-94-52) relating to S&P MidCap 400 Depositary Receipts. Publication of the approval order is expected in the <u>Federal Register</u> during the week of March 27. (Rel. 34-35534)

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-95-8). The proposal extends through October 2, 1995 certain of the prior changes to its Small Order Execution System that were scheduled to expire on March 27, 1995. (Rel. 34-35535)
