COMMISSION ANNOUNCEMENTS

COMMUNIQUE RELEASED AT COSRA MEETING

The Commission today released a communique describing the progress made at the Fourth Annual Meeting of the Council of Securities Regulators of the Americas (COSRA) which was held on May 29-30, 1995, in Sao Paulo, Brazil. The meeting was hosted by the Comissao de Valores Mobiliarios of Brazil, and chaired by the SEC and the Comision Nacional de Valores of Argentina. At the meeting, COSRA adopted ground-breaking principles vital to accomplishing market integrity by providing a framework for the development of effective market oversight in each of the COSRA participants' countries. The principles include the appropriate use of government regulation and self-regulation.

ENFORCEMENT PROCEEDINGS

ENFORCEMENT ACTION AGAINST MAL YERASI

On May 30, the Commission filed a complaint in the United States District Court for the Southern District of New York against Mal Yerasi. The complaint alleges that Yerasi violated Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. In its complaint, the Commission seeks a permanent injunction and disgorgement plus prejudgment interest. Yerasi's alleged wrongful conduct stemmed from his submission of at least 43 fraudulent proofs of claim for monies from claims funds established in connection with settlements of private securities fraud class actions and three additional claims from disgorgement funds established in connection with Commission enforcement actions. COMPLAINT FILED AGAINST JOHN NAKOSKI

The Commission announced that on May 30 it filed a complaint against defendant John T. Nakoski (Nakoski).

The complaint alleges as follows: Nakoski defrauded approximately thirty-five investors of approximately \$450,000 by means of a "Fixed Income Loan Agreement" (Note), pursuant to which he guaranteed principal and 15% or 12% interest on investments through his investment business. Nakoski misrepresented the safety of the Notes and the use of investors' monies. Nakoski used investors' money to invest in futures and futures options and for personal and business expenses. In addition, Nakoski illegally acted as an unregistered investment adviser and violated certain custody and disclosure requirements.

Simultaneously, and without admitting or denying the allegations in the Commission's complaint, Nakoski consented to the entry of a Final Judgment enjoining him from violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, and Sections 203(a) and 206(1), (2), and (4) of the Investment Advisers Act of 1940, and Rules 206(4)-2 and 206(4)-4 thereunder; he also consented to the entry of an administrative order barring him from the securities industry.
