# ENFORCEMENT PROCEEDINGS

CEASE AND DESIST PROCEEDINGS INSTITUTED AND SETTLED AGAINST DONALD STOECKLEIN

The Commission instituted and settled cease and desist proceedings pursuant to Section 8A of the Securities Act of 1933 and Section 21C of the Securities Exchange Act of 1934 against Donald J. Stoecklein for violating the securities registration and the antifraud provisions of the federal securities laws.

Stoecklein has submitted an Offer of Settlement which the Commission has determined to accept. In his Offer, Stoecklein, without admitting or denying the findings, consents to the issuance of an Order by the Commission which finds that Stoecklein directed the sale in the United States public markets of 190,000 shares of SoftPoint, Inc. stock that had been puportedly issued to foreign entities under Regulation S promulgated under the Securities Act, which is a safe harbor from registration for offshore offerings. The Order further finds that Stoecklein then distributed the proceeds from the sale of the "Reg S" stock to SoftPoint and other individuals and entities. The Order also finds that Stoecklein's sale of the Reg S stock that had been issued to the foreign entities, and his subsequent distribution of most of the

proceeds to SoftPoint, were part of a fraudulent scheme engaged in by SoftPoint, Inc. and certain other individuals and entities to raise capital for SoftPoint.

Pursuant to the Order, Stoecklein is ordered to cease and desist from committing or causing any violations and any future violations of the securities registration and the antifraud provisions of the federal securities laws. Stoecklein is also ordered to pay disgorgement in the amount of \$19,975, plus prejudgment interest. (Rels. 34-36177; AAER-706)

KEYPORT LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 25 to request a hearing on an application by Keyport Life Insurance Company, KMA Variable Account, Keyport Variable Account I, Independence Life and Annuity Company (formerly, Keyport America Life Insurance Company), Independence Variable Annuity Separate Account (formerly, Keyport America Variable Annuity Separate Account), Independence Variable Life Separate Account (formerly, Keyport America Variable Life Separate Account), Liberty Life Assurance Company of Boston and Variable Account-K. The applicants seek an order, pursuant to Sections 17(b) and 26(b) of the Investment Company Act, approving the substitution of shares of the Managed Assets Fund for shares of the Strategic Managed Assets Fund, each of which is a portfolio of SteinRoe Variable Investment Trust (SteinRoe Trust); shares of SteinRoe Trust's Mortgage Securities Income Fund for shares of the Colonial-Keyport U.S. Government Fund of Keyport Variable Investment Trust (Keyport Trust); and shares of Keyport Trust's Colonial-Keyport Strategic Income Fund for shares of SteinRoe Trust's Managed Income Fund. # VAN KAMPEN MERRITT EQUITY TRUST, ET AL.

A notice has been issued giving interested persons until September 25 to request a hearing on an application filed by Van Kampen Merritt Equity Trust, et al., for an order under Section 17(b) of the Investment Company Act that would exempt applicants from Section 17(a) of the Act. The order would permit the Van Kampen Merritt Utility Fund, a subtrust of the Van Kampen Merritt Equity Trust, to acquire all of the assets of the American Capital Utilities Income Fund, Inc. Because of certain affiliations, the two funds may not rely on Rule 17a-8 under the Act. (IC-21331 - August 31)

# HOLDING COMPANY ACT RELEASES

LEIDY HUB, INC., ET AL.

An order has been issued authorizing a proposal by National Fuel Gas Company (NFG), a registered public utility holding company, and Leidy Hub, Inc. (Leidy Hub), its nonutility subsidiary. Leidy Hub proposes to acquire an interest in Enerchange, a company formed to develop, implement and operate an electronic gas trading and nomination system to be incorporated as QuickTrade. In addition, Leidy Hub and NFG propose to make loans to Enerchange and to guarantee certain obligations of Leidy Hub, Enerchange and QuickTrade. (Rel. 35-26365)

# SELF REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGES

The <u>National Securities Clearing Corporation</u> filed a proposed rule change (SR-NSCC-95-12) under Section 19 (b) (2) of the Securities Exchange Act. The proposed rule change modifies the amount of a member's required clearing fund deposit that may be collateralized by letters of credit. Publication of the proposed rule change is expected in the <u>Federal Register</u> during the week of September 4. (Rel.34-36172)

The Commission received a proposed rule change filing (SR-Amex-95-32) by the <u>American Stock Exchange</u> on July 31, 1995, proposing to list and trade options on the Amex HMO Index. Publication of the notice is expected to appear in the <u>Federal Register</u> during the week of September 4. (Rel. 34-36175)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission has granted approval of a proposed rule change (SR-Phlx-95-43) by the <u>Philadelphia Stock Exchange</u> relating to the minimum opening transaction size for customized foreign currency options. Publication of the order is expected to appear in the <u>Federal Register</u> during the week of September 4. (Rel.34-36176; ISR-847)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-95-35), and the Commission issued an order granting accelerated approval, to delay the implementation of the NASD's Primary Market Maker standards and extend the duration of the pilot program for the NASD's Short Sale Rule from March 5, 1996 until June 3, 1996.
