COMMISSION ANNOUNCEMENTS

BARRY BARBASH TO TESTIFY

Barry Barbash, Director of the Division of Investment Management, will testify on Tuesday, October 31, at two separate hearings held by the House Subcommittee on Telecommunications and Finance.

The first hearing, which concerns H.R. 1495, the Investment Company Act of 1995, will be held at 9:30 a.m. in Room 2322 of the Rayburn House Office Building. The second hearing, which concerns H.R. 2519, the Philanthropy Protection Act of 1995, will be held at 2:30 p.m. in Room 2123 of the Rayburn House Office Building.

COMMISSION'S CONSUMER AFFAIRS ADVISORY COMMITTEE MEETING

The Commission's Consumer Affairs Advisory Committee will meet on November 15 in Room 1C30 at the Commission's Headquarters beginning at 9:00 a.m. The meeting will be opened to the public. The Committee will consider and review Commission developments on investor initiatives such as descriptions of risk in mutual funds, profile prospectuses, new rules governing municipal securities, proposals to improve trading prices for investors, compensations practices, arbitration and other current issues. ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE AND CEASE AND DESIST PROCEEDINGS AGAINST NICHOLAS HOWARD

On October 30, the Commission issued an Order instituting administrative and cease and desist proceedings against Nicholas P. Howard. In the Order the Division of Enforcement alleges that Howard, who during the relevant period was head of European equity sales at James Capel Inc. (a registered broker dealer) and a managing director of New Europe Hotels N.V. (NEH), aided, abetted, counseled, commanded or procured and caused violations of Rule 10b-9 of the Exchange Act and the antifraud provisions in connection with a part or none offering by NEH in January 1991 and a subsequent offering in November 1991. The Division also alleges that Howard aided, abetted, counselled, commanded or procured and caused violations of Section 17(a)(1) of the Investment Company Act of 1940 in connection with the sales of NEH shares to a registered investment company.
