### COMMISSION'S CONSUMER AFFAIRS ADVISORY COMMITTEE MEETING

## ENFORCEMENT PROCEEDINGS

### BOILER-ROOM DEFENDANTS BARRED FROM SECURITIES INDUSTRY

The Commission announced the issuance of an order barring Michael W. Adams, Donald H. Stringer, Victor G. Campana, and Saint Clair Ainsley Knight, Jr., from the securities industry. The order was based upon the entry of permanent injunctions against the four individuals in SEC v. Norman L. Brooks, et al., Civil Action No. 94-0167-JD (D.N.H.), an action brought on April 5, 1994, to stop an on-going fraudulent, "boiler-room" offering of unregistered securities that raised more than \$3.5 million from more than 100 investors nationwide.

The order also was based upon Knight's entry of a guilty plea in a state criminal action based upon the same misconduct. Each of the four individuals consented, without admitting or denying the Commission's substantive allegations, to the issuance of the order.

In the injunctive action, the Commission alleged that the offering involved materially false statements to investors, including representations that the proceeds of the offering would be used to make automobile loans the repayment of which was "insured." In fact, most of the proceeds of the securities sales were converted to the personal benefit of the offering's participants. Adams and Knight were ordered in the civil action to pay disgorgement and prejudgment interest of approximately \$32,000 and \$17,000, respectively. (Rel. 34-36454)

#### LEE SUTLIFFE ENJOINED

The Commission announced that on October 27 the United States District Court for the Western District of Missouri entered an Order of Permanent Injunction against Lee F. Sutcliffe (Sutcliffe), enjoining him from future violations of the antifraud provisions of the federal securities laws. Sutcliffe consented to the entry of the Order without admitting or denying the allegations in the Commission's complaint.

The Commission's complaint, filed on September 27, alleged that two not-for-profit corporations largely controlled by Sutcliffe, First Humanics Corp. (First Humanics) and its successor, International Elderly Care, Inc. (IEC), acquired 26 nursing homes through 26 public offerings of municipal and corporate bonds raising over \$107 million. In connection with two such offerings, Sutcliffe, who acted as a promoter of the offerings and participated in the drafting of the offering circulars, made misrepresentations and omissions of material fact concerning his role as a promoter, his control over the not-for-profit corporations as well as his regulatory history and numerous prior bond and business failures, the commingling of revenues from earlier First Humanics nursing home acquisitions and the resulting financial interdependence of all First Humanics homes, an ongoing Ponzi scheme involving First Humanics homes, and the nexus between IEC and First Humanics.
