Featured Speakers

United States Attorney Carmen M. Ortiz District of Massachusetts



United States Attorney Carmen M. Ortiz, the chief federal law enforcement officer in Massachusetts, is the first Hispanic and the first woman to represent Massachusetts as United States Attorney. In 2010, she implemented the District's first civil rights initiative, aimed at reinvigorating enforcement efforts of federal civil rights laws and increasing visibility among affected communities through extensive community outreach efforts. Ms. Ortiz, confirmed in 2009, is a member of the Attorney General's Advisory Committee (AGAC) and sits on the civil rights subcommittee.

Cheryl Brown Henderson



Ms. Brown Henderson is the daughter of the late Rev. Oliver L. Brown who, in 1950, along with 12 other parents, filed suit on behalf of their children against the Topeka Board of Education. This led to the landmark Supreme Court case Brown v. Board of Education.

Theodore C. Landsmark



Theodore C. Landsmark is the president of the Boston Architectural College. A participant in the Selma to Montgomery marches in the 1960s, he was also the subject of a famous 1976 Pulitzer Prize-winning photograph that showed him being attacked by a man with an American flag on the steps of Boston's Government Center, during an anti-busing rally. Landsmark is a recipient of The Whitney M. Young Jr. Award for his work as a social activist.
