Dr. Michael Bourke, Chief Psychologist U.S. Marshals Service, Behavioral Analysis Unit

Dr. Michael Bourke was deputized by the U.S. Marshals Service in 2008. Prior to that, he worked as a clinical psychologist for the federal prison system at the Federal Correctional Institution in Butner, NC. Specifically, he was assigned to the Sex Offender Treatment Program (SOTP) and Hypersexuality Management Program (HMP) between 2000 to 2006, and worked with the Commitment and Treatment Program for Sexually Dangerous Persons (CTP) between 2006 and 2008. Dr. Bourke is a

graduate of the Department of Defense Polygraph Institute, and he has conducted several hundred polygraph examinations of sex offenders. He is a regular consultant to federal, state, and local law enforcement agencies on matters pertaining to sexual criminality, interviewing/interrogation techniques, and psychological safeguarding of law enforcement personnel.
