Public Law 112—95, Section 813 requires airport sponsors requesting revenue exemptions meet certain conditions, agreements, and obligations including, but not limited to, allocating revenue identified by the Administrator for federal, state, or local transportation infrastructure projects carried out by the airport sponsor or by a governing body within the geographical limits of the airport sponsor’s jurisdiction, as prescribed in Section 813(b).

Accordingly, I hereby acknowledge and agree to:

I affirm that no part of the project(s) identified for revenue use exemption will be funded with other forms of federal aid unless specifically identified and the funding is not duplicative. The revenue identified for exemption may be used as local matching funds but may not be used toward fees and costs associated with the project for which the sponsor will receive other public funding.

I understand a condition for exemption requires the airport sponsor to certify each year, on a date mutually agreeable to the sponsor and FAA, a financial statement that identifies the amount of exempted revenue used to date and the remaining amount available. [See Appendix F-1, *Sponsor Annual Project Financial Statement*] I further acknowledge that FAA may request and the sponsor will provide, within 60 days of such request, documentation supporting statements made in the annual financial statement.

I understand that FAA may require a copy of the RFP(s) selected be provided to FAA as part of this application. I understand that failing to provide FAA with copies of selected RFP(s) may deem this application incomplete and absolves FAA from meeting any timelines identified in prior communications.

¹ An airport sponsor may request revenue be exempted for more than one eligible project with its application. The airport sponsor must submit use Table E to identify and explain each proposed project. Only one Project Certification Form with accompanying Table E is required for each sponsor application.
