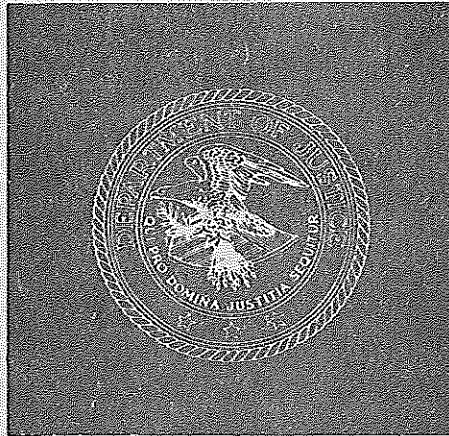

WORK HANDLED BY UNITED STATES ATTORNEYS' OFFICES

DURING FISCAL YEAR 1972

CRIMINAL CASES

FILED - Criminal filings amounting to 52,023 showed an increase of 6143 or 13.3 per cent from the number filed in the previous fiscal year. 79.7 per cent of the total was in 16 offenses having 700 or more cases; 14 showed increase while 2 showed a decrease. Increases occurred in Bank Robbery (1891 to 1992), Weapons Control (1791 to 2500), Selective Service (4724 to 5431), Postal Crimes (3371 to 3555), Narcotics (5232 to 7087), Income Tax (906 to 1065), National Motor Vehicle Act dropped from 2857 to 2706. Increases took place in 67 districts ranging from 1 in Arkansas Western to 1403 in the Texas Western. Decreases took place in 26 districts ranging from 1 in Montana to 337 in California Southern.

TERMINATED - Cases terminated increased 7789 or 18.5 per cent, over the previous year's total. Of the total or 49,737 closed, 28,735 involving 34,928 defendants were pleas of guilty, 4432 (involving 5884 defendants) were found guilty after trial and 1511 (involving 2252 defendants) were found not guilty (including 31 not guilty verdicts by reason of insanity.)

PENDING - With 29,556 cases, the pending caseload showed an increase of 8.3 per cent over the 27,270^{*} cases pending at the close of fiscal year 1971. Of the pending cases, 14,822 cases were awaiting arraignment in court or trial, while 1853 were awaiting sentence. 6333 are fugitives and 462 in other status beyond the control of the United States Attorney.

GRAND JURY PROCEEDINGS

Grand Jury proceedings, comprised of 31,840 indictments and 193 No True Bills, amounted to 32,033 an increase of 9.3 per cent over the previous fiscal year.

CRIMINAL COMPLAINTS

RECEIVED - Complaints received increased to 185,822; this is 16.9 per cent more than the 158,824 received in fiscal year 1971. California Southern with 24,021 had the most complaints and Texas Western with 18,162 and California Central with 10,704 were the next highest. 121,559 of the complaints were in eleven offenses as shown below:

PENDING - Criminal Complaints pending as of June 30, 1972 dropped to 32,102 a decrease of 3,808 or 10.6 per cent less than the 35,910 pending as of June 30, 1971.

CLOSED - 138,723 Complaints were closed during 1972 without reaching court dockets. Of this number 119,064 or 85.8 per cent of the total were closed by declination of prosecution.

CIVIL CASES

FILED - Civil Cases filed amounted to 33,413 an increase of 3,064 or 10.1 per cent more than the previous year's total. 64 districts had increases and 29 districts showed decreases from the previous year. 15,651 or 46.8 per cent of the total was in eighteen districts having filings ranging from 660 to 1,261. Tax Lien cases with 4,529, Tort cases with 2,076 and General Claims cases with 3,257 had 13.6, 6.2 and 9.7 per cent respectively of the cases filed.

TERMINATED - With 62 Districts showing increases and 29 districts with decreases, civil cases terminated increased to 31,367. This total is over fiscal year 1971 total by 2,425 or 8.3 per cent.

3,963 of these cases were suits in which the government as defendant was sued for \$195,728,318. 765 of them involving \$67,931,471 were closed by compromises amounting to \$20,314,070 and 826 involving \$39,040,557 resulting in judgments against the government amounting to \$13,965,497. The remaining 2,372 cases involving \$88,756,240 were won by the government, thus bringing the savings to \$161,448,751, a decrease of \$3,718,801 or 2.3 per cent from the \$165,167,552 saved in Fiscal Year 1971.

PENDING - Civil cases pending as of the close of the fiscal year increased by 2,046 or 6.1 per cent to 32,057. 12,520 or 39.1 per cent of the caseload was in twelve districts with caseloads ranging from 623 in Michigan Eastern to 2,084 in New York Southern. Tax Lien cases with 5,121 increased to 16.0 per cent of the total as compared to 4,752 or 15.8 per cent of the total pending as of June 30, 1971. Land cases with 1,867 or 5.8 per cent decreased from 1,923 or 6.4 per cent of the total.

CIVIL MATTERS

RECEIVED - Civil Matters received amounted to 36,161, an increase of 2,258 or 6.6 per cent more than the 33,903 in Fiscal Year 1971. Tax Lien matters with 4,407 and Tort matters with 2,100 comprised 12.1 per cent and 5.8 per cent respectively of the total. Delegated General Claims matters amounted to 4,139 or 11.4 per cent of the total. 12,572 or 34.7 per cent of the total was in twelve districts having totals ranging from 827 in Pennsylvania Eastern to 1,478 in New York Eastern.

TERMINATED - Civil matters terminated without reaching court dockets amounted to 7,063 an increase of 34.7 or 1,818 from the fiscal year 1971 total of 5,245.

PENDING - 11,325 civil matters were pending as of June 30, 1972 as compared to 11,396 as of June 30, 1971. This is a decrease of 71 or .62 per cent.

MAN-HOURS

A total of 353,667 man-hours were spent in court during Fiscal Year 1972. This is an increase of 44,098 or 14.2 per cent over Fiscal Year 1971. Following is a breakdown of those hours:

Based on an average employment of 1,065.8 each Assistant United States Attorney averaged 33.2 hours per month in courtroom work during the fiscal year. This compares with an averaged 34.9 hours per month in Fiscal Year 1971.

COLLECTIONS

Collections for Fiscal Year 1972 amounted to \$85,694,714, a decrease of \$9,153,188 or 9.6 per cent less than the \$94,847,902 collected in Fiscal Year 1971.

PERSONNEL

During the year United States Attorneys' employment averaged 2,508 employees and 2,456 were on the rolls as of June 30, 1972. Cases handled per Assistant United States Attorney decreased from 144.6 in Fiscal Year 1971 to 133.9 in the current year while cases terminated decreased from 79.9 to 76.1.

Cases Pending in United States Attorneys' Offices

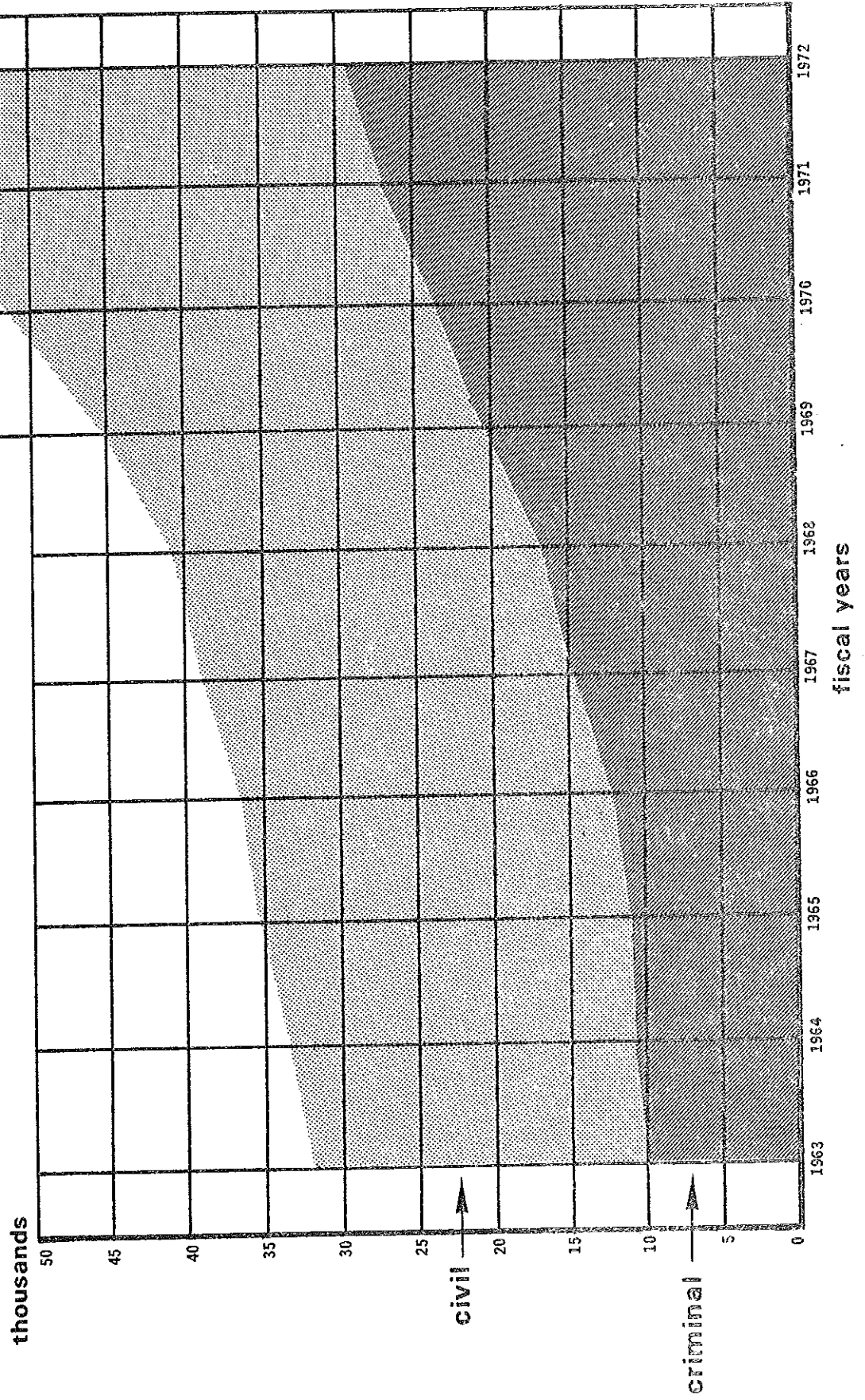

Criminal and Civil Cases Filed in United States Attorneys' Offices

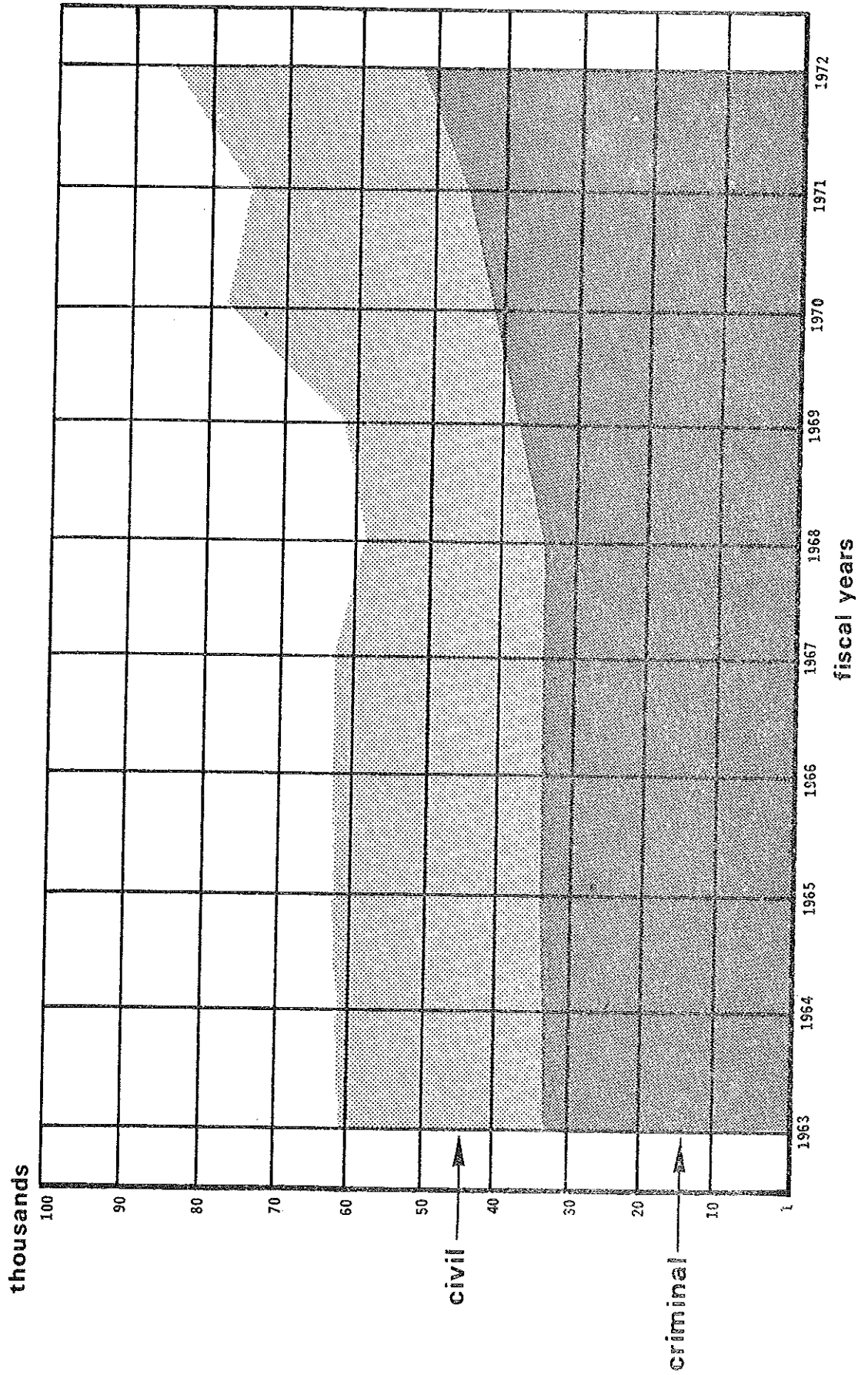

Criminal and Civil Cases Terminated in United States Attorneys' Offices

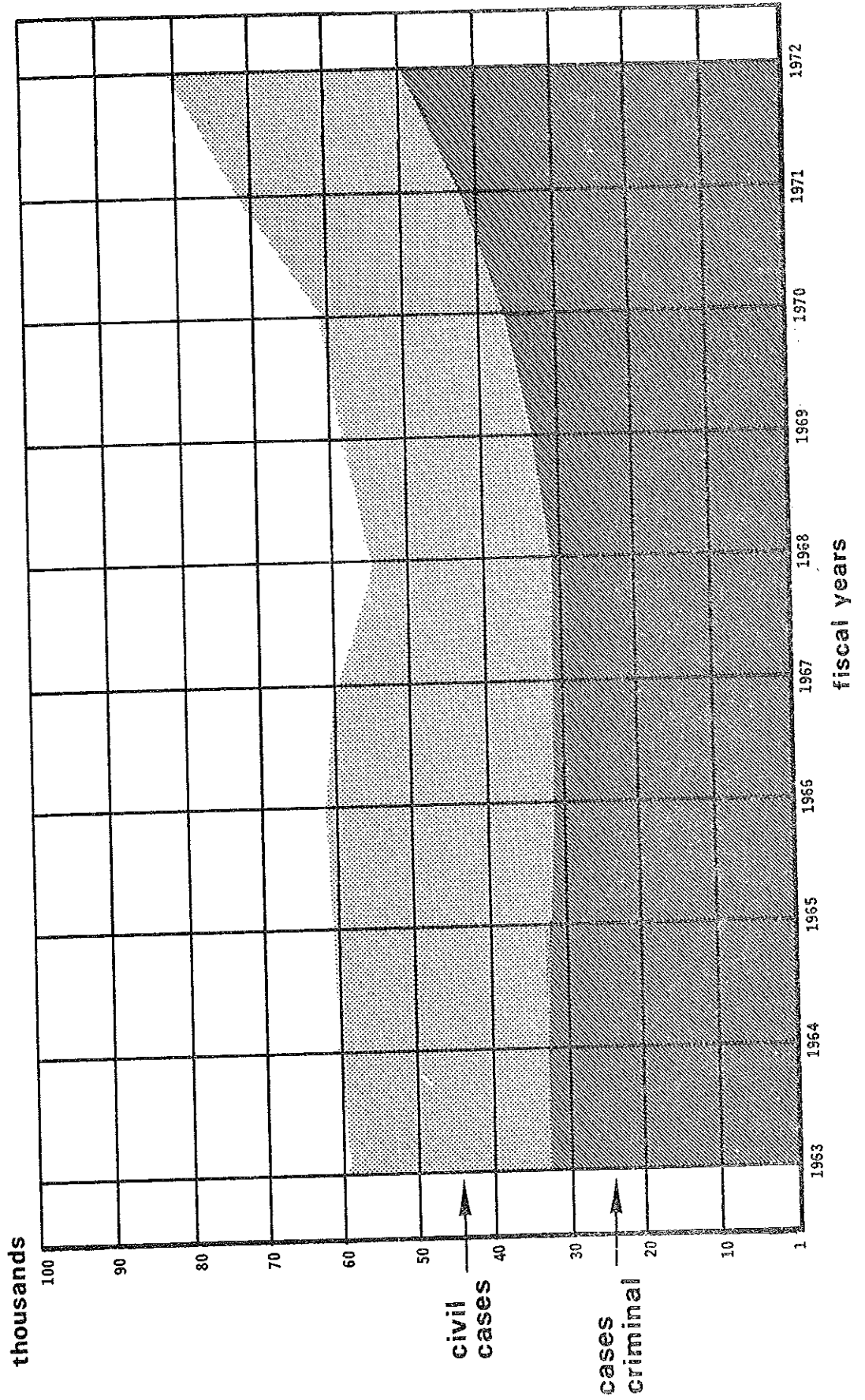

Criminal and Civil Matters Received in United States Attorneys' Offices

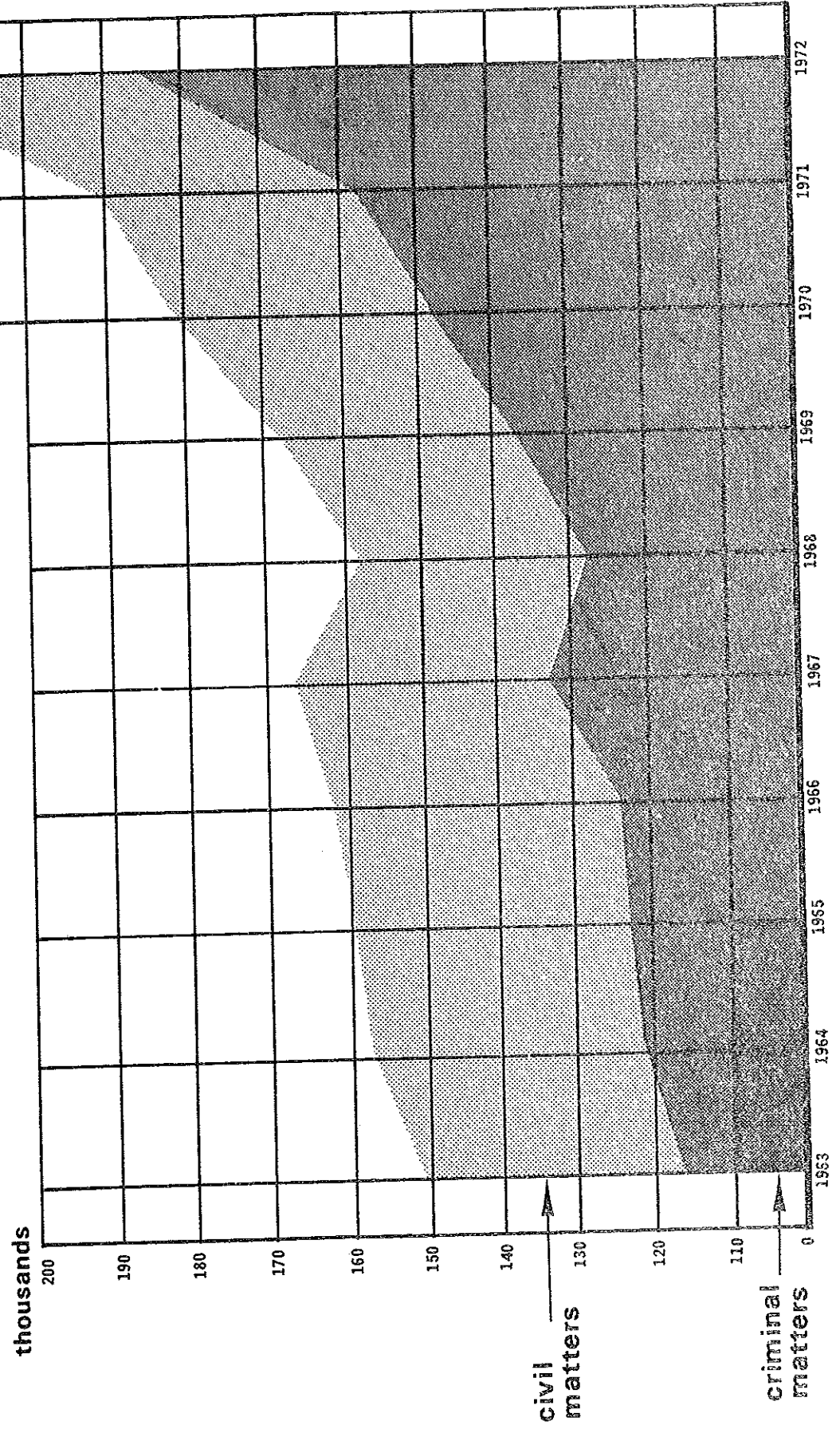

Trials in Criminal and Civil Cases in United States Attorneys' Offices

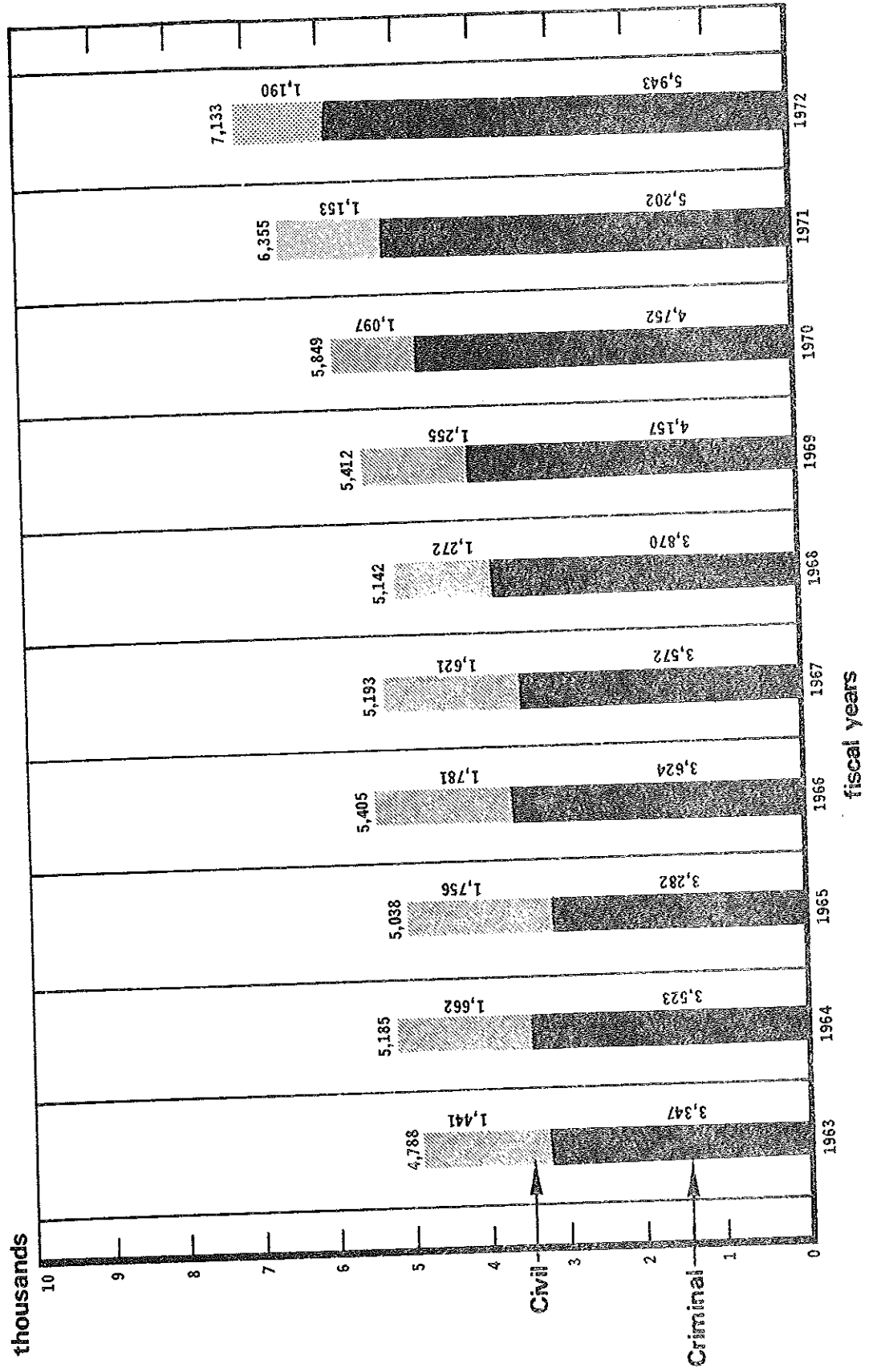

Total 29,556 Cases**

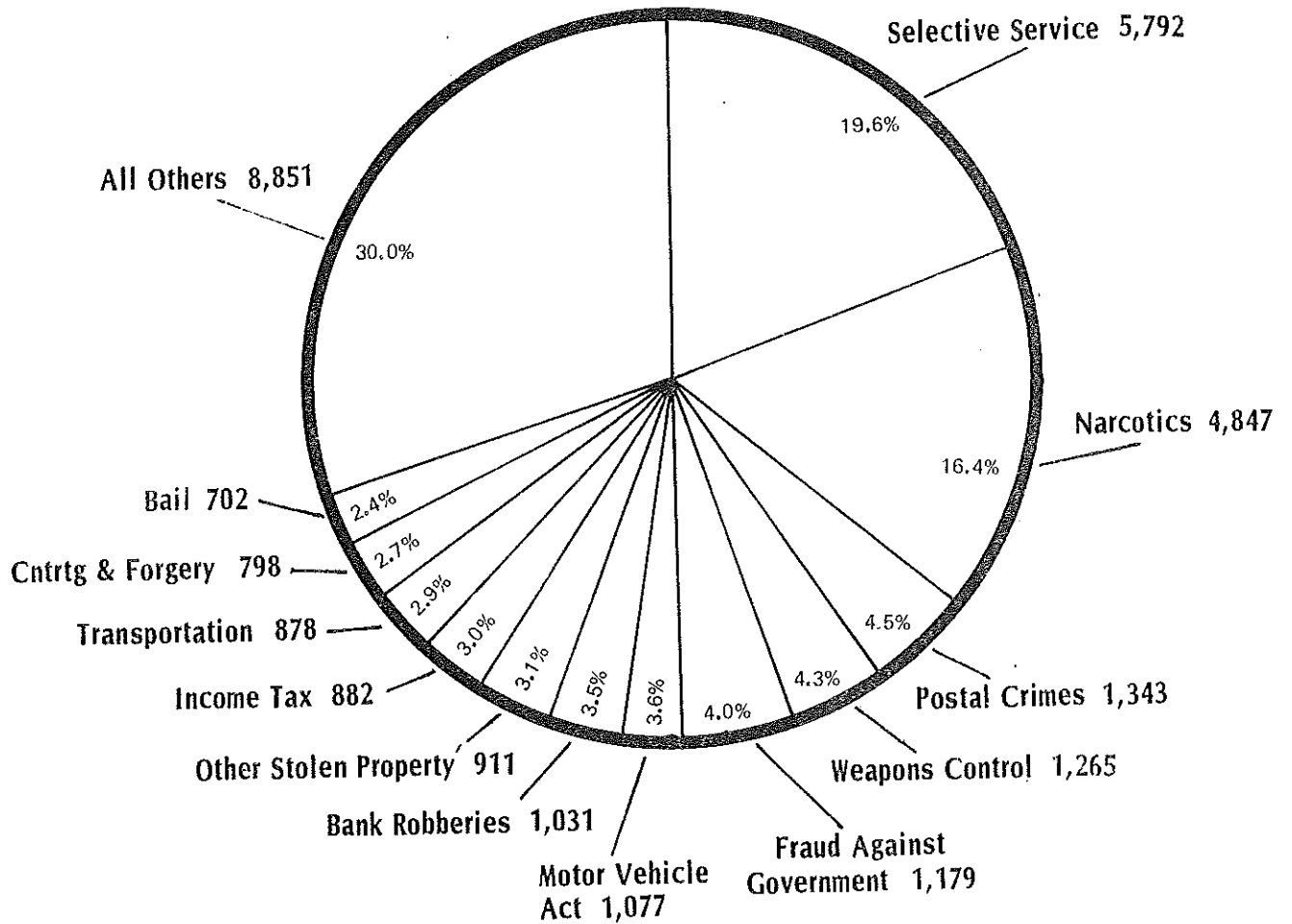

Total 29,556 Cases

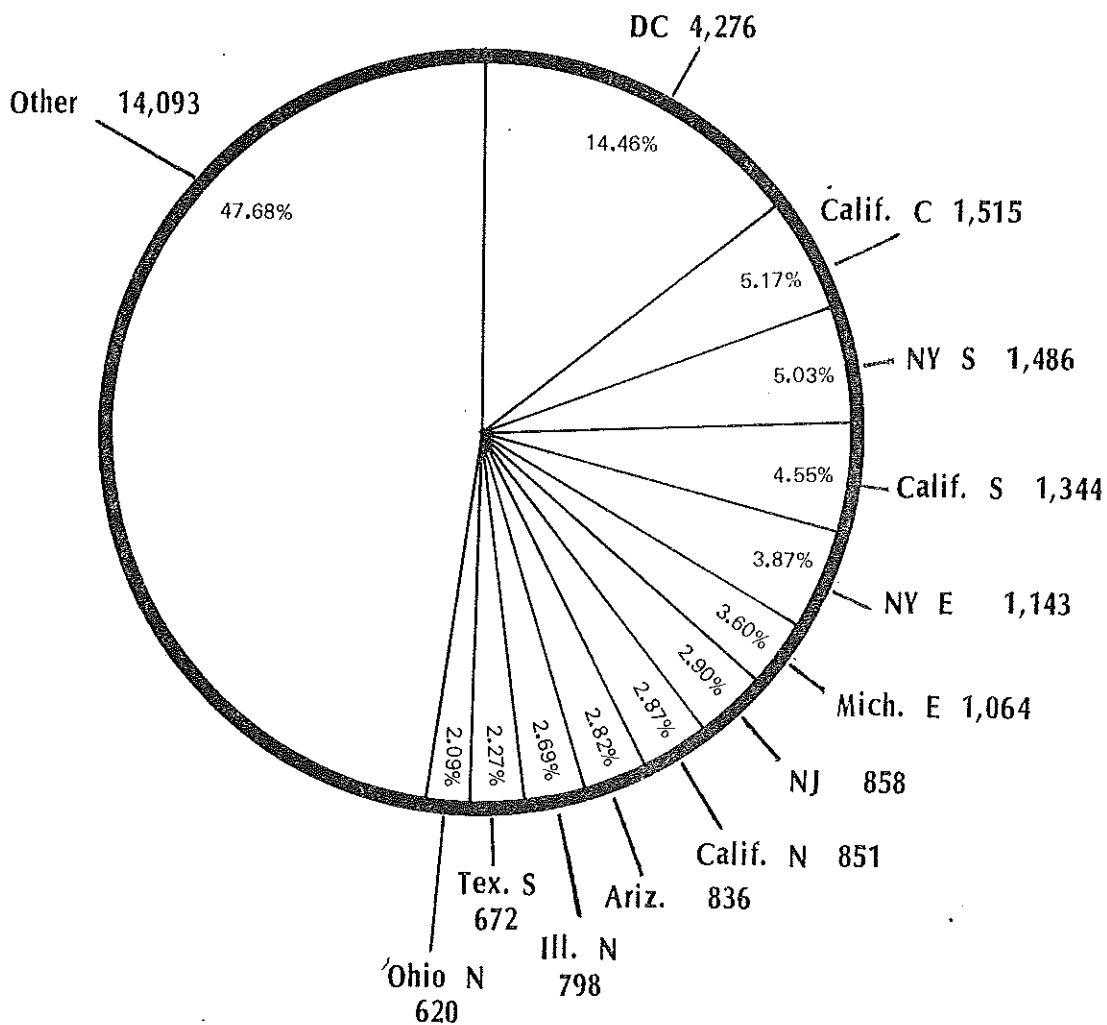

Criminal Cases Filed in United States Attorneys' Offices

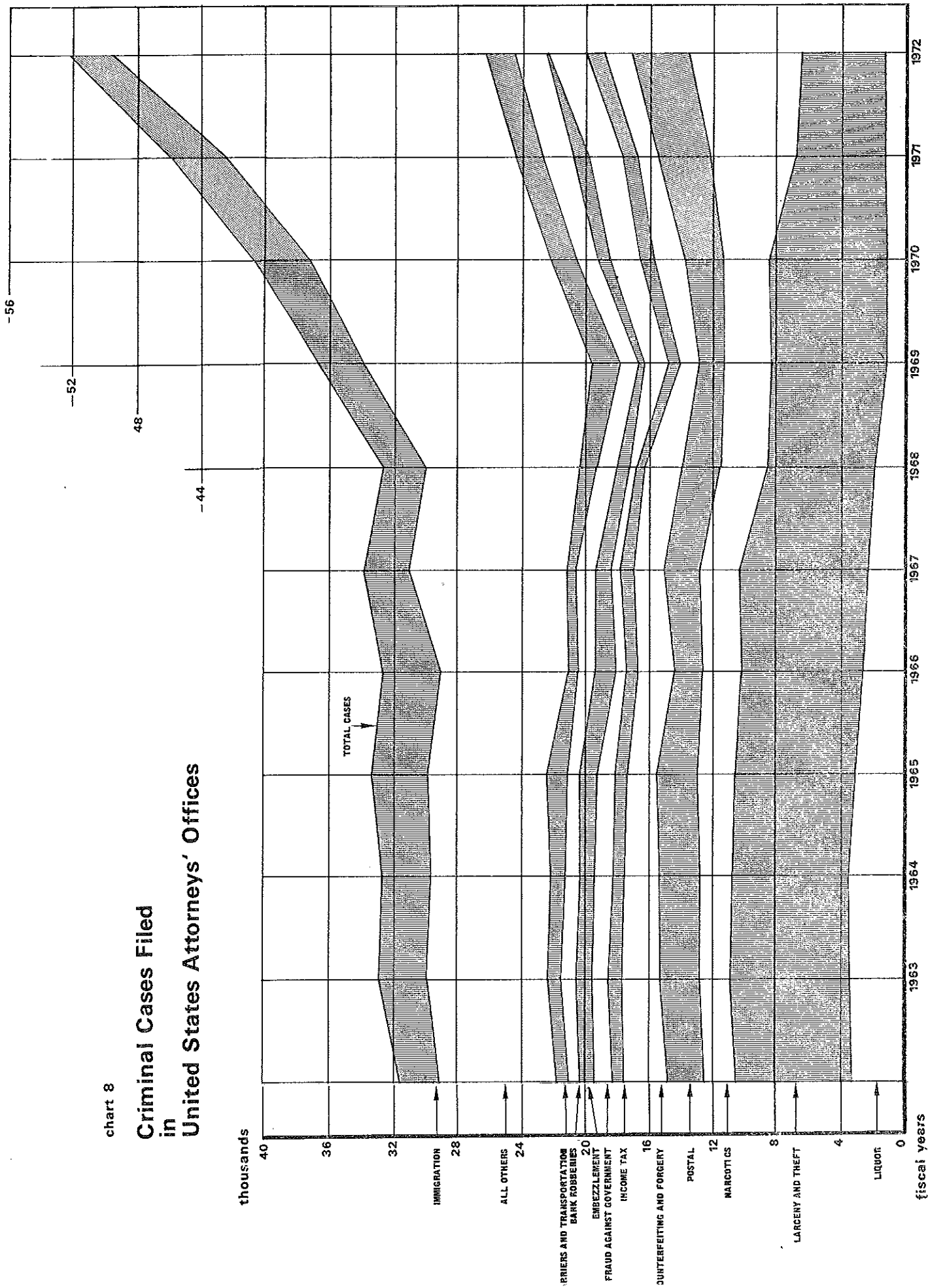

United States Attorneys' Offices

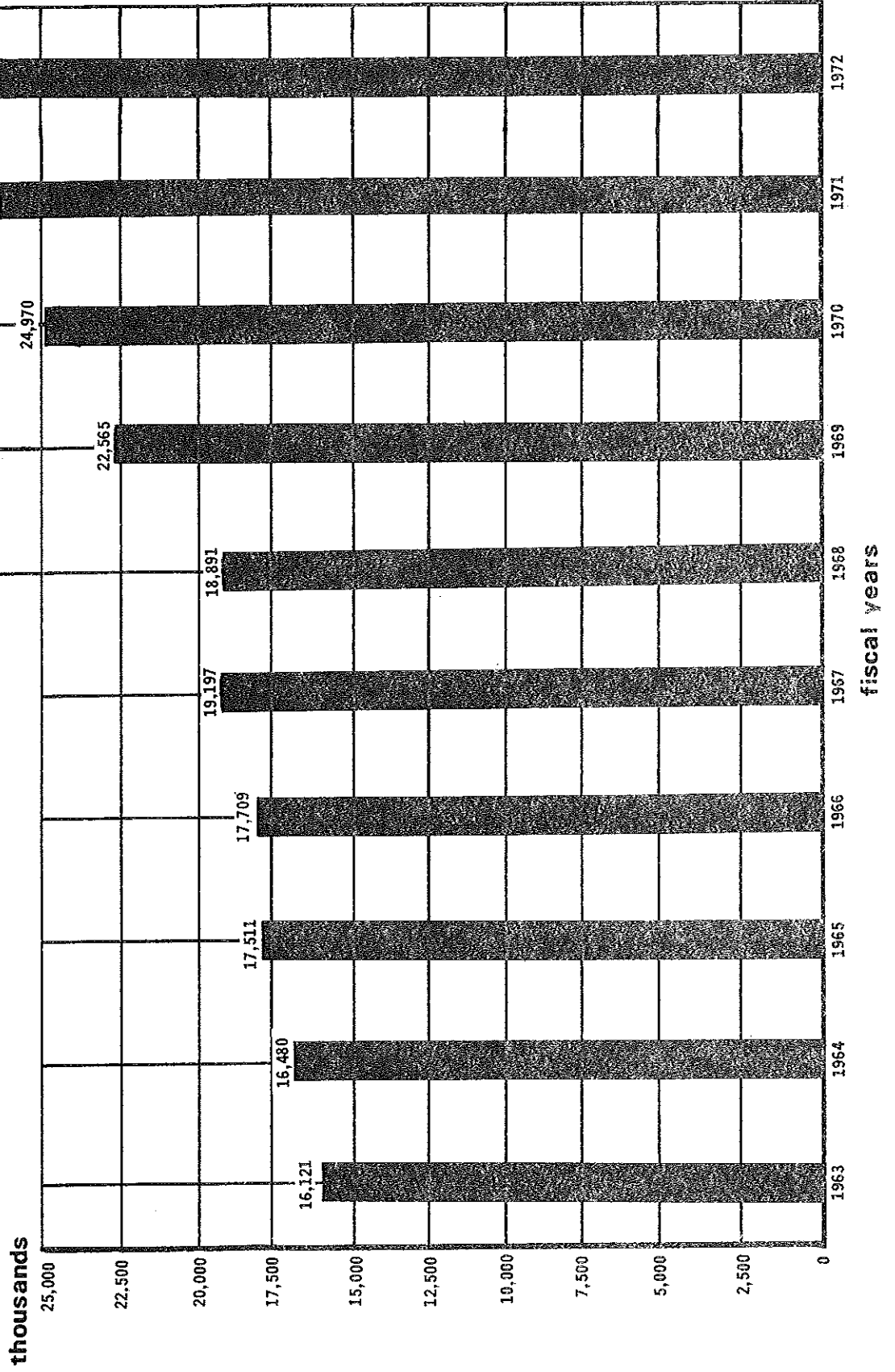

Total Cases Criminal 29,556 Civil 30,190

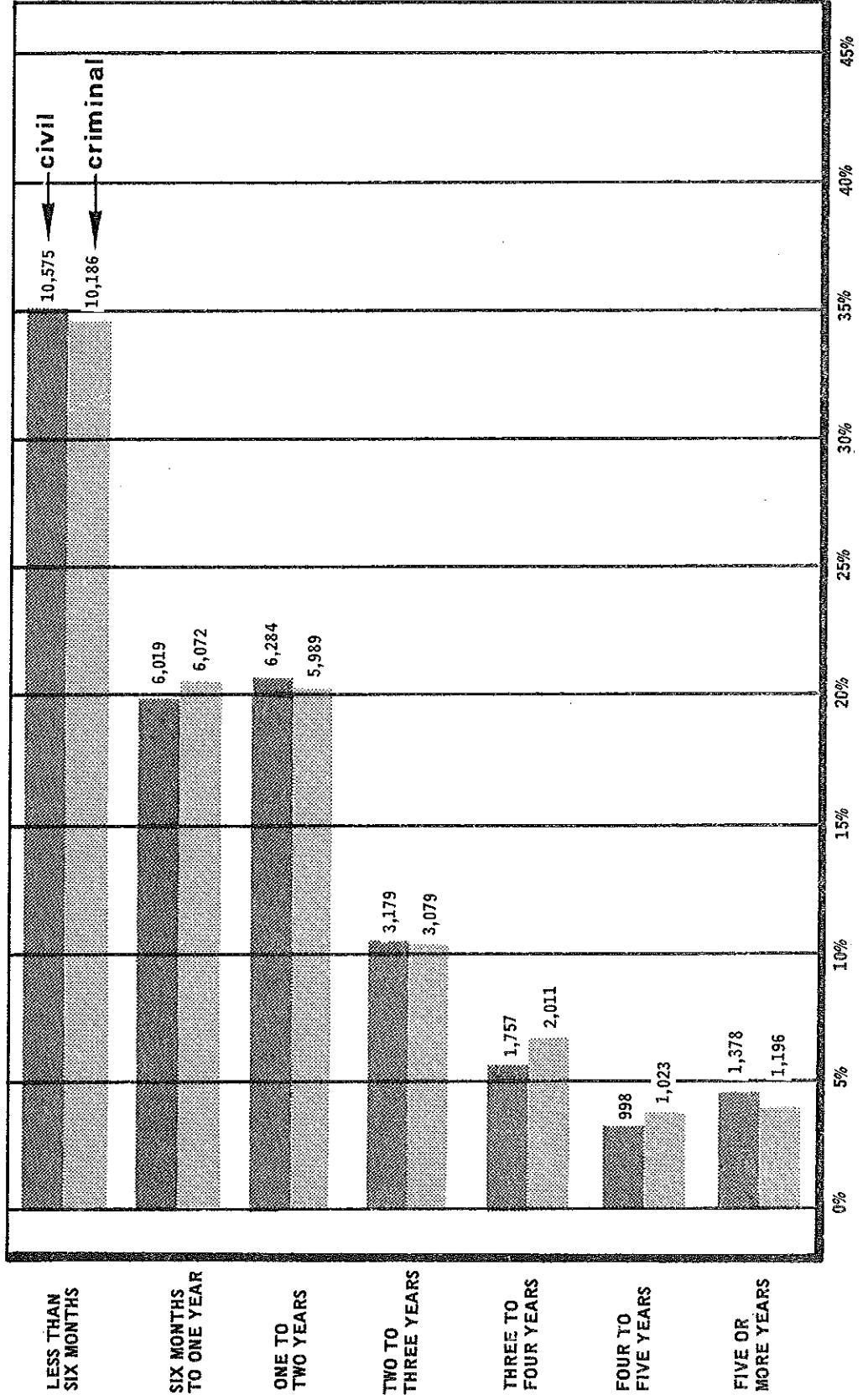

Total 32,057 Cases**

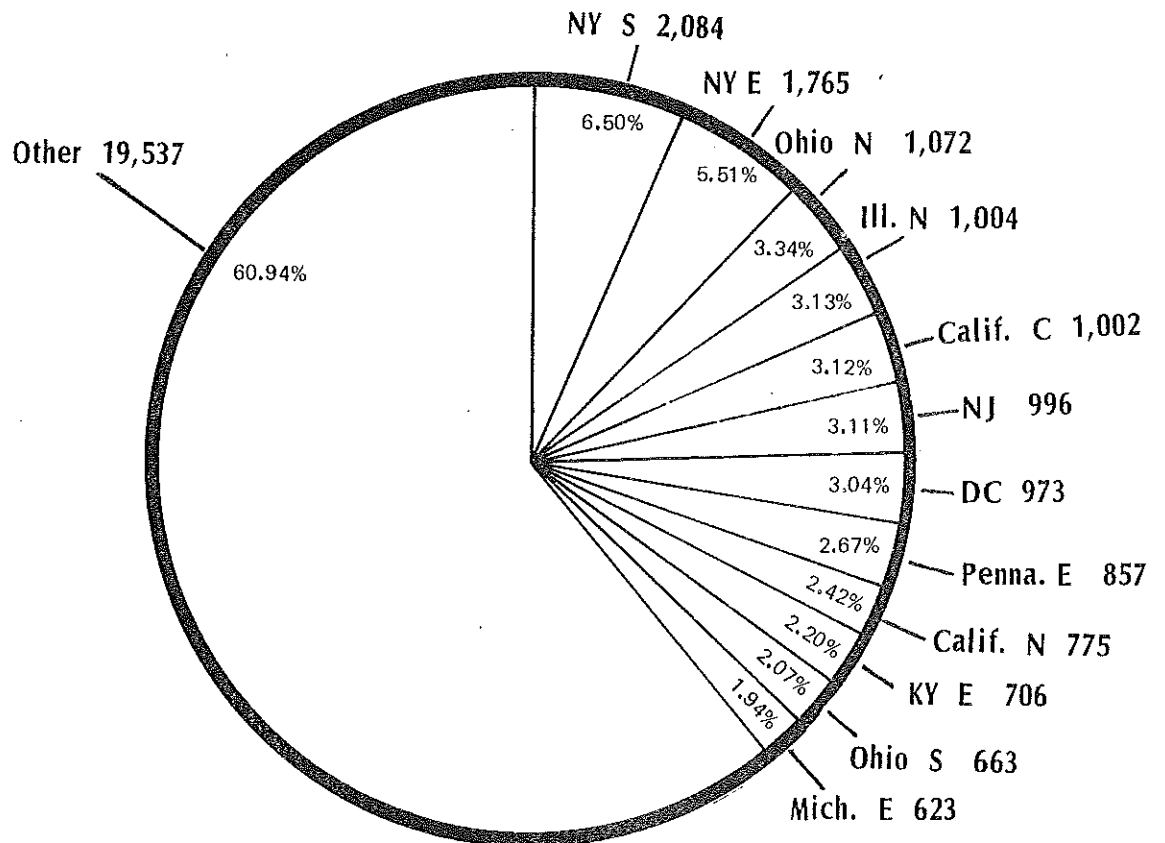

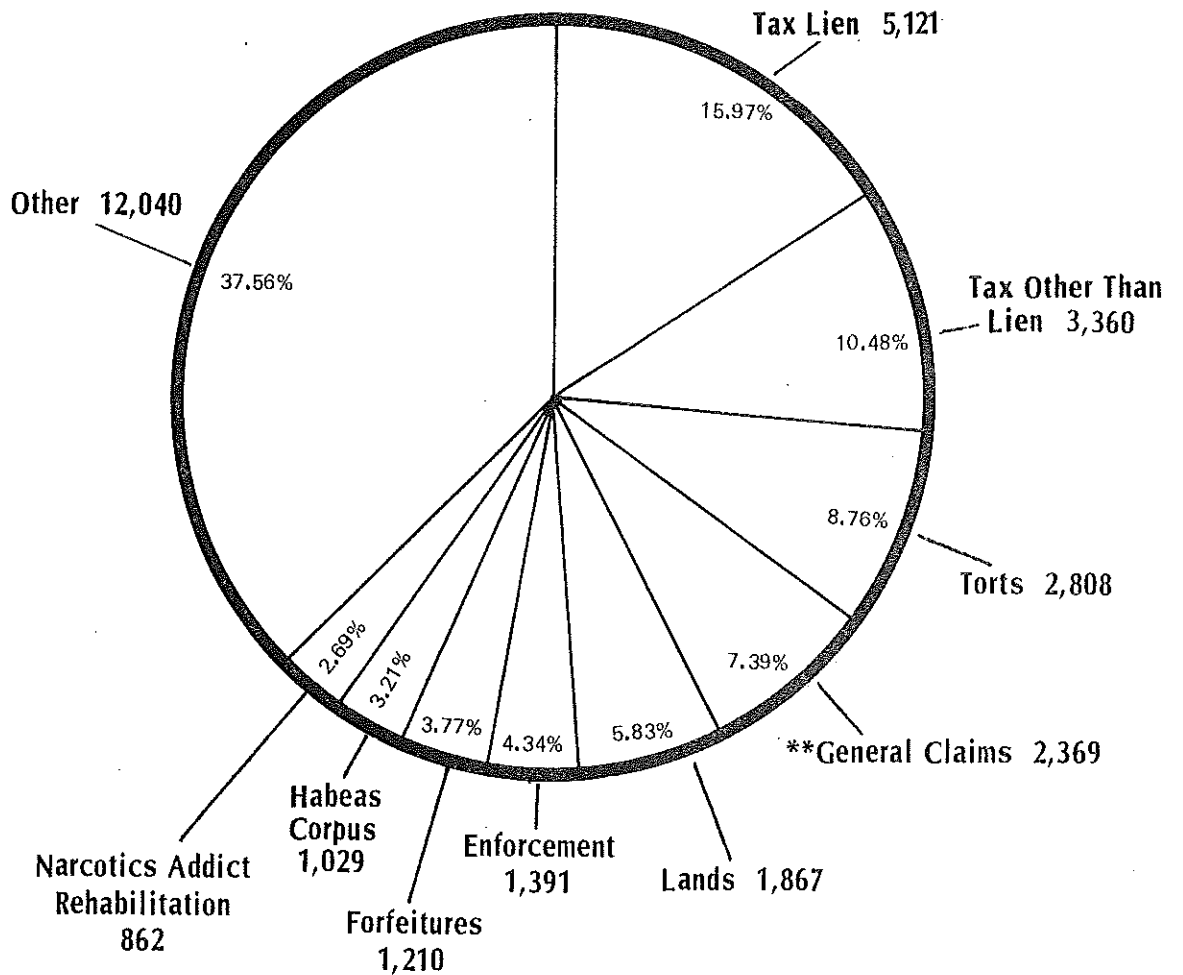

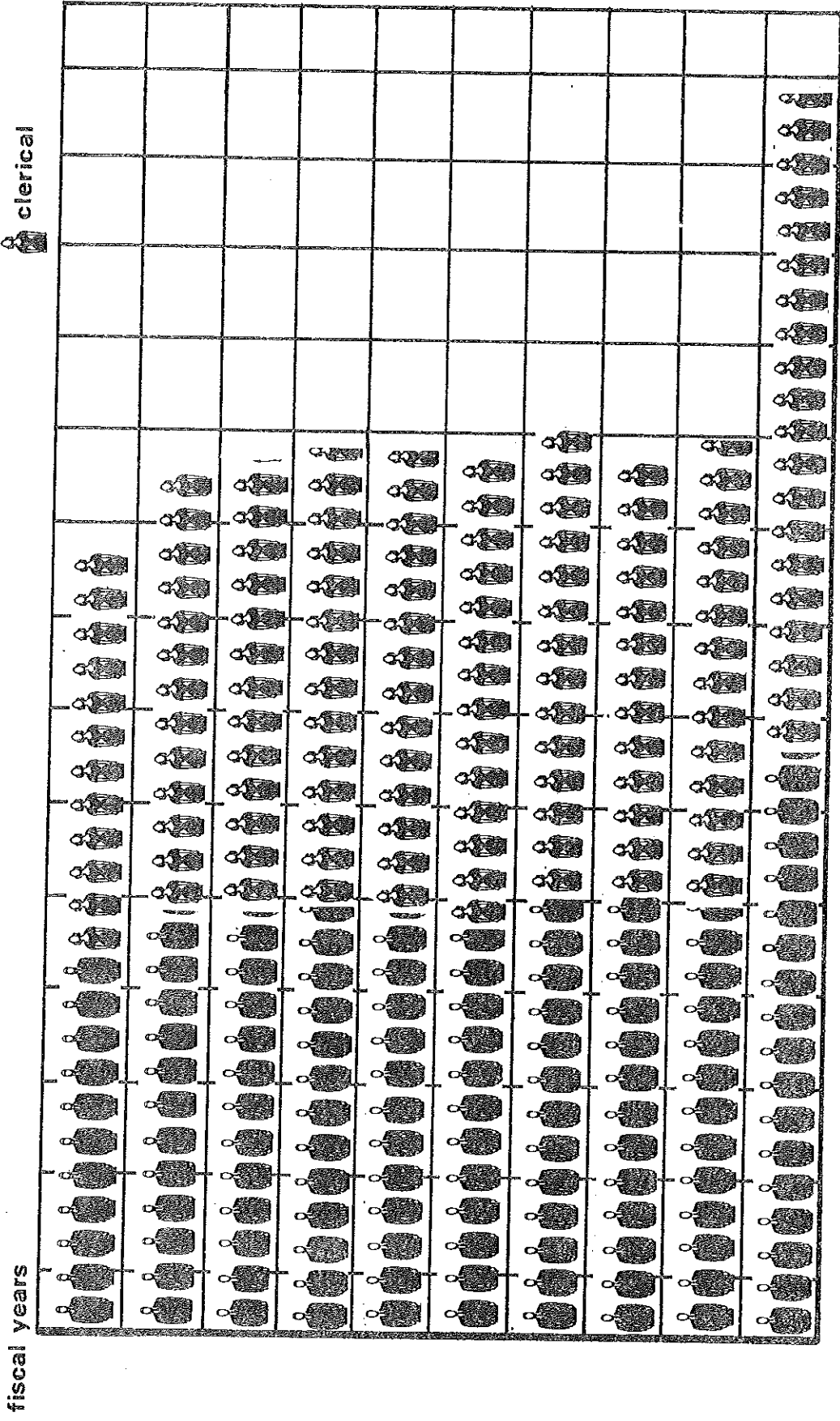
