

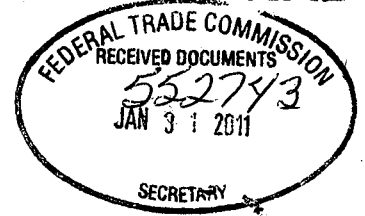

**RESPONDENT PROMEDICA HEALTH SYSTEM, INC.'S
UNOPPOSED MOTION TO PLACE ANSWER ON THE PUBLIC RECORD**

Respondent ProMedica Health System, Inc. (“ProMedica”) respectfully moves for an order placing a copy of Respondent ProMedica Health System, Inc.’s Answer to Complaint (“Answer”), which ProMedica filed *in camera*, on the public record.

On January 6, 2011, the FTC placed a redacted version of its Complaint on the public record. The redacted portions of the Complaint included quotations from certain documents and other materials that were protected from disclosure during the pre-complaint investigation.

On January 24, 2011, the FTC filed an unopposed motion to place an unredacted copy of its Complaint on the public record because a virtually identical copy of the Complaint was unsealed in the related district court proceeding and the Complaint did not contain any competitively sensitive information. The ALJ granted the FTC’s motion on January 26, 2011.

In the meantime, ProMedica filed its Answer on January 25, 2011. ProMedica placed a redacted version of the Answer on the public record and submitted an unredacted version for *in camera* review. ProMedica only filed two versions of its Answer because it incorporated the Complaint allegations that the FTC previously submitted under seal. Now that the ALJ has unsealed those Complaint allegations and because a virtually identical copy of the Answer has been unsealed in the related district court proceeding, ProMedica respectfully requests that the ALJ enter an order placing an unredacted copy of the Answer on the public record. Counsel for the FTC has informed ProMedica’s counsel that they do not intend to oppose this motion.

WHEREFORE, Respondent ProMedica Health System Inc. respectfully requests that the ALJ grant its motion and place an unredacted copy of the Answer on the public record.
