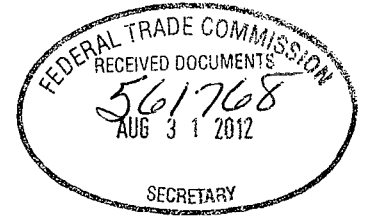

**ORDER ON STAR PIPE PRODUCTS, LTD.'S
MOTION FOR *IN CAMERA* TREATMENT**

By Order dated August 17, 2012, the motion for *in camera* treatment filed by non-party Star Pipe Products, Ltd. ("Star"), was ruled upon. (August 17, 2012 Order).
