THIRD UNOPPOSED MOTION FOR EXTENSION OF TIME TO MOVE TO LIMIT SUBPOENA

Non-party International Business Machines Corporation ("IBM") files this third motion for a brief extension of time for IBM to file a motion to limit Rambus Incorporated's ("Rambus") Subpoena Duces Tecum which was issued October 8, 2002.

Rambus served IBM with the subpoena on October 24, 2002. Under the applicable procedures, the time to file a motion to limit the Subpoena would have been November 4, 2002. On November 4th IBM filed its First Unopposed Motion for Extension of Time to Move to Limit Subpoena and on November 13th filed its Second Unopposed Motion on the same subject.

Counsel for IBM and for Rambus conferred several times in the attempt to resolve IBM's concerns about the scope and other issues relating to the Subpoena. Rambus agreed to withdraw certain requests, to narrow others and to continue to negotiate with IBM about the scope of still other requests. Counsel are still in the process of negotiating in an attempt to resolve IBM's concerns regarding the scope and burden of the Subpoena. However, due to the complexity of the issues and the scope of the Subpoena, and the fact that Rambus' counsel was

largely unavailable late last week due to jury duty, IBM and Rambus have not completed their negotiations.

IBM and Rambus have agreed to an extension of time to file a motion to limit the Subpoena to November 27, 2002. The extension is not sought for delay, but only to allow for the possible resolution of certain issues relating to IBM's obligations under the Subpoena.

Counsel for Rambus does not oppose this extension.

Accordingly, IBM requests that this motion be granted and that it be given until November 27, 2002 to file a motion to limit the Subpoena.
