FILE COMMENTS ON RESPONDENTS' REMEDY PROPOSAL**


Complaint Counsel respectfully move the Federal Trade Commission for an order extending the time to file objections or comments on Respondent's Proposed Final Order until October 29, 2007. Our objections or comments are currently due on October 17, 2007. This is our first request for an extension of time.

The need for the extension is that, as a consequence of previously scheduled travel, complaint counsel will be out of the office until two days before the objections or comments are now due. Also, an extension will give us additional time for several divisions within the Bureau of Competition and the Bureau of Economics to review Respondent's proposed final order thoroughly and to prepare objections and comments that may assist the Commission in its development of a final order.

In a conversation on September 21, 2007, with Duane M. Kelly, Esq., respondents authorized us to advise the Commission that they do not oppose this motion.

PROPOSED ORDER GRANTING MOTION FOR EXTENSION OF TIME

On August 2, 2007, the Commission issued an Order in this matter that, *inter alia*, required Respondent Evanston Northwestern Healthcare Corporation to file with the Commission, on or before September 10, 2007, a detailed proposal for implementing the type of injunctive relief that the Commission has selected, as described by the Opinion of the Commission and the Commission Order; that requires Complaint Counsel to file with the Commission any objections to or comments on that proposal within thirty calendar days thereafter; and that requires Respondent to file any response to Complaint Counsel's filing within ten calendar days thereafter. By Order dated September 10, 2007, the Commission extended the time for Respondent's filing until September 17, 2007. Respondent filed its Proposed Final Order on that date.

Complaint Counsel has now filed a Motion requesting an extension of the deadline for filing their objections or comments on Respondent's Proposed Final Order until October 29, 2007.

The need for the extension is that, as a consequence of previously-scheduled travel, Complaint Counsel will be out of the office until two days before the objections or comments are currently due. Also, an extension will give Complaint Counsel additional time for several divisions within the Bureau of Competition and the Bureau of Economics to review Respondent's proposed final order thoroughly and to prepare objections and comments that may assist the Commission in its development of a final order. Complaint Counsel further advises

that Respondent does not oppose the Motion, provided that Respondent will still have ten days within which to file their response after Complaint Counsel has filed its objections and comments.

The Commission has determined to grant the Motion, Accordingly,

IT IS ORDERED that the deadline prescribed in the Sixth Ordering Paragraph in the Commission Order issued in this matter on August 2, 2007, be, and hereby is, extended until until October 29, 2007; and

IT IS FURTHER ORDERED that the deadline prescribed in the Seveth Ordering Paragraph in the August 2, 2007, Ortder remain unchanged.


