SUBJ: Traffic Flow Management (TFM) System

- 1. Purpose of This Notice. This notice amends FAA Order JO 7210.3, Facility Operation and Administration, to ensure the new functions associated with the scheduled upgrade to Traffic Flow Management (TFM) system software (referred to as "Release 5/6" or "R5/6") that introduce new capabilities for TFM equipment to interface with ERAM are not used until ERAM is completely operational in the entire National Airspace System. This change adds new entries to the Explanation of Terms and adds field facility responsibilities.
- **2. Audience**. This notice applies to the following Air Traffic Organization (ATO) service units: En Route and Oceanic, Terminal, Mission Support, and System Operations, including the managers of tactical operations (MTO) and traffic management officers (TMO).

- **4. Procedures**. Amend FAA Order JO 7210.3, paragraphs 17-18-3 and 17-18-5, to read as follows:

17-18-3. EXPLANATION OF TERMS

Title thru f, no change.

- **g.** Protected Segment: The protected segment is a segment on the amended TFM route that is to be inhibited from automatic adapted route alteration by ERAM.
- **h.** Protected Segment Indicator: The protected area will be coded on the display and strips using the examples in TBL 17-18-1.

i. TMI Indicator: This denotes protected coding exists for a flight's route even though the coding within the route may be scrolled off the view surface.

j. TMI Identifier: Identifies the name of the initiative and is inserted into the beginning of Interfacility Remarks after the clear weather symbol.

6. Not amend flight plans for flights outside their area of jurisdiction without prior approval.
